#### News From the Third Judicial Circuit January 18, 2022

Philadelphia – The Courts, Community, and Rule of Law Committee of the Judicial Council of the Third Circuit announced today that it is hosting an essay contest for 5th and 6th grade classes focused on civics, citizenship, and the concept of the "Rule of Law." The essay prompt is: "What does the Rule of Law mean to you and to our country?"

The Third Judicial Circuit is comprised of the U.S. Court of Appeals as well as the Federal District Courts of Pennsylvania, New Jersey, Delaware, and the U.S. Virgin Islands. The latter are trial courts, which include bankruptcy courts. Chief Circuit Judge Michael A. Chagares noted that "We think it is only fitting that we launch this program in connection with Martin Luther King, Jr. Day, as we celebrate the life and legacy of Dr. King, an example of how individual citizens can advance the notion that our society should recognize the dignity of each and every citizen." The Rule of Law plays a key role in that effort by ensuring the consistent and predictable application of law to each person.

The Committee and its members are partnering with bar associations, civic organizations, and educational institutions across the geographical reach of the Third Circuit to promote and oversee the essay contest. Class essays must be submitted on or before Friday, March 18, 2022. Classes submitting the best essays in each district (District of Delaware, District of New Jersey, Eastern District of Pennsylvania, Middle District of Pennsylvania, Western District of Pennsylvania, and the District of the Virgin Islands) of the Third Circuit will be invited to one of the nine courthouses in the Third Circuit to present their essays during the first weeks of May, in celebration of Law Day. The essays and presentations will be evaluated based on focus, content development, organization, and style and prizes will be awarded.

Judge D. Brooks Smith, who chairs the Courts, Community, and Rule of Law Committee overseeing the contest, urged that "It is important, now more than ever, that the citizenry realize that our courts are an integral part of the community. An understanding of what we do as the third branch of government in promoting the rule of law will help students appreciate the importance of our independent judiciary."

#### Commonwealth v. Gomez

Motion to Suppress — Traffic Stop — Warrantless Arrest — DUI — Probable Cause — Medical Marijuana Act — Odor of Marijuana Opinion. Commonwealth of Pennsylvania v. Deeanne Larae Gomez. No. 3275-2020.

OPINION BY: ASHWORTH, P.J., SEPTEMBER 24, 2021. Before the Court is Defendant Deeanna Larae Gomez's Omnibus Pretrial Motion to suppress the results of chemical testing conducted pursuant to a warrantless arrest on suspicion of driving under the influence. Defendant is charged with: DUI, first offense (impaired ability); possession of a controlled substance, small amount/personal use (marijuana, non-prescription); possession of drug paraphernalia; DUI, first offense (controlled substance: non-medically prescribed marijuana); DUI, first offense (metabolite), and two summary traffic offenses, all stemming from a traffic stop occurring on May 6, 2020.2 Having considered the Defendant's Omnibus Pretrial Motion, the briefing of the parties, and a hearing on the matter, the Motion to Suppress will be denied.

#### I. BACKGROUND

At the evidentiary hearing on July 14, 2021, the parties agreed that Pennsylvania State Trooper Michael Artale (Trooper Artale), the reporting law enforcement officer, would testify accurately and consistently with his detailed official report (Report), which was duly admitted as Commonwealth's Exhibit #1. No additional testimony was offered. The facts recited herein are therefore drawn from the Report.

On May 6, 2020, Trooper Artale was conducting a stationary traffic patrol shortly before midnight when Defendant's car passed him travelling at a high rate of speed and with an unilluminated right taillight. After pulling his vehicle onto the road behind Defendant's car, Trooper Artale clocked her speed by radar at 75mph in a posted 65mph speed limit zone. At that time, Trooper Artale initiated a traffic stop,<sup>3</sup> and upon approach of the car, detected the smell of burnt marijuana emanating from the passenger compartment. Trooper Artale also observed that Defendant, the driver and sole occupant of the car, had a disheveled appearance with glassy and bloodshot eyes. The Defendant voluntarily admitted to smoking marijuana approximately one to two hours prior to the stop.4 Trooper Artale then asked Defendant to exit the

Defendant filed her Omnibus Pre-trial Motion on September 27, 2020, at which time the Court was operating under the continuing judicial emergency necessitated by the COVID-19 pandemic. On July was operating under the continuing judicial energency necessitated by the COVID-19 pandermic. On July 14, 2021, the Court conducted an evidentiary hearing on the omnibus motion. Defendant filled a brief in support on August 4, 2021, and the Commonwealth filed its reply brief on August 13, 2021.

In violation of 75 Pa.C.S.A. §3802(d)(2); 35 Pa.C.S.A. 780-113(a)(31); 35 Pa.C.S.A. 780-113(a) (32); 75 Pa.C.S.A. §3802(d)(1)(i), 3804(c)(1); and 75 Pa.C.S.A. §38302(d)(1)(iii), 3804(c)(1), respectively.

Defendant does not contest the legality of the initial traffic stop.

The traffic stop began at 11:50 p.m. when Trooper Artale stopped the Defendant for speeding and the unilluminated taillight. Defendant initially said she had smoked marijuana earlier at either 10:00

p.m. or 11:00 p.m.; she later clarified it was closer to 10:00 p.m. when she had smoked.

vehicle, after which he conducted a search of the same. No additional evidence of contraband or criminal activity was discovered.5

Subsequent to the search, Trooper Artale administered a number of standard field sobriety tests (SFSTs) to Defendant, the details of which are stated with specificity in the Report. In summary, Trooper Artale noted signs of impairment as follows: Defendant began tests too soon multiple times, was unable to maintain balance during instructions, swayed during balancing tests, exhibited rapid eyelid tremors consistent with impairment, touched the pad rather than the tip of her finger to her nose several times, frequently moved her head toward her finger, and neither of her eyes converged upon testing. After administering the SFSTs and noting these signs of impairment, Trooper Artale placed the Defendant under arrest on suspicion of driving under the influence and illegal possession of marijuana. Before Trooper Artale conducted a search of Defendant's person pursuant to the arrest, Defendant admitted that she had marijuana in her pocket and withdrew a marijuana cigarette. The ensuing search yielded an additional plastic bag containing a small amount of marijuana and rolling paper. The Defendant was then transported to Lancaster General Hospital where she underwent a blood draw for chemical testing.

#### II. DISCUSSION A. Arguments

In her motion, Defendant contends the Pennsylvania legislature's passage of the Medical Marijuana Act (MMA),6 legalizing possession and use of marijuana in limited circumstances, has thrown the law into flux regarding whether and to what extent the odor of marijuana can be considered by police officers in evaluating probable cause to make a warrantless arrest upon a traffic stop.7 Defendant argues the Superior Court's decision in Commonwealth v. Barr, 240 A.3d 1263 (Pa. Super. Ct. 2020), appeal granted, 252 A.3d 1086 (Table), directly applies to this matter, and stands for the proposition that because possession of marijuana is no longer a per se criminal violation, the odor of marijuana can no longer provide the sole basis for either reasonable suspicion or probable cause for warrantless police action. The Defendant concludes that "speeding at 10 MPH over the speed limit, plus an odor of marijuana and bloodshot eyes is not enough to provide reasonable grounds for chemical testing" and the results of the testing should therefore be suppressed. Def. Br. in Supp. at 7 (unpaginated).

The Commonwealth responds that Barr is inapplicable because that case addresses a warrantless search and the instant case concerns a warrantless arrest. In the alternative, the Commonwealth contends

that even if Barr does apply to the facts of this matter, Barr stands for the proposition that post MMA, a police officer may still properly consider the odor of marijuana as one among other factors when considering if probable cause exists for a warrantless arrest, and in this particular case, the facts and the totality of the circumstances do support a finding of probable cause.

#### B. Analysis

Where a motion to suppress has been filed, the burden is on the Commonwealth to establish by a preponderance of the evidence that the challenged evidence was not obtained in violation of a defendant's rights. Pa. R.Crim.P. 581(H); Barr, 240 A.3d at 1273; accord Commonwealth v. Wallace, 42 A.3d 1040, 1047-48 (Pa. Super. Ct. 2012)(en banc).

By virtue of driving a car in the Commonwealth of Pennsylvania, an individual grants implied consent to chemical testing for the presence of a controlled substance "if a police officer has reasonable grounds to believe the person to have been driving, operating or in actual physical control of the movement of a vehicle in violation of . . . [75 Pa.C.S.A. §] 3802 (relating to driving under influence of alcohol or controlled substances)." 75 Pa. C.S.A. §1547 (emphasis added). Furthermore, a police officer may make a warrantless arrest during a traffic stop if there is "probable cause to believe that the individual has violated . . . [75 Pa.C.S.A. §] 3802 (relating to driving under the influence of alcohol or controlled substances)." 75 Pa. C.S.A. §3811(a) (emphasis added).

The determination of whether to arrest for DUI is made by a police officer in light of all the facts and circumstances available. Generally, probable cause for a warrantless arrest exists when the facts and circumstances within the police officer's knowledge and of which the officer has reasonably trustworthy information are sufficient in themselves to warrant a person of reasonable caution in the belief that an offense has been committed by the person to be arrested. Probable cause justifying a warrantless arrest is determined by the totality of the circumstances.

Commonwealth v. Salter, 121 A.3d 987, 996–97 (Pa. Super. Ct. 2015) (citing Commonwealth v. Williams, 941 A.2d 14, 27 (Pa.Super.2008) (internal quotations and citations omitted)). Moreover, it is the facts and circumstances within the personal knowledge of the police officer that frames the determination of the existence of probable cause. See, e.g., Commonwealth v. Lawson, 454 Pa. 23, 27, 309 A.2d 391, 394 (1973) ("Probable cause exists if the facts and circumstances known to the officer warrant a prudent man in believing that an offense has been committed."); Commonwealth v. Galendez, 27 A.3d 1042, 1046 (Pa. Super. 2011) (en banc) (emphasis in original). Commonwealth v. Weaver, 76 A.3d 562, 565 (Pa. Super. 2013), aff'd per curiam, — Pa. ——, 105 A.3d 656 (2014).

Salter, 21 A.3d at 997.

The threshold question for this Court is whether and to what extent the Superior Court's decision in Barr applies to the matter before us now. In Barr, the Commonwealth challenged the trial court's finding that after passage of the MMA, a police officer is prohibited from considering the odor of marijuana as a factor in the probable cause analysis for a warrantless automobile search during a traffic stop. The Commonwealth argued the MMA did not change the plain smell doctrine, which it interpreted as a per se rule that the odor of marijuana alone would always provide police officers with probable cause to conduct a warrantless search.

Finding the Commonwealth's argument erroneous, the Barr Court first clarified the nature of the plain smell doctrine under Pennsylvania precedent, emphasizing the doctrine has never created the per se rule urged by the Commonwealth. Rather, the Court explained, the existing rule, properly stated, is that the odor of marijuana may alone be sufficient to establish probable cause to search in particular factual contexts. In practical terms, historically, the circumstances wherein the odor of marijuana would not alone be sufficient to establish probable cause were necessarily rare or even nonexistent when marijuana was, in all or virtually all circumstances, illegal to possess . . . . [t]he trial court was free to weigh the inference of criminality implied by the odor of marijuana against other relevant facts known to the officers in determining whether they possessed probable cause to conduct the search.

Barr, 240 A.3d at 1275-76 (emphasis in original). The Barr Court further opined that the plain smell doctrine was crafted over the years "in light of the previously universal fact of marijuana's illegality and its distinctive odor. The MMA has clearly altered the underlying factual context in which that probable cause test applies." Id. at 1278.

In examining how the MMA might alter application of the plain smell doctrine, the Barr Court held that even after passage of the MMA, "the odor of marijuana may still be indicative of an illegal or criminal act, because the possession of marijuana remains generally illegal. This is especially true when other circumstances suggest that the detected marijuana cannot be in compliance with the MMA." Id. at 1286. The Court emphasized the well-settled principle that individualized suspicion is a primary concern for courts considering the constitutionality of a warrantless search or seizure. See Barr, 240 A.3d at 1287. Mindful of this need for individualized suspicion, the Court found that after the MMA, the odor of marijuana remains relevant to the probable cause analysis, but with a diminished significance. Under the MMA, the Court reasoned, many Pennsylvania citizens are now legally allowed to consume marijuana. Thus, [t]he odor of marijuana alone, absent any other circumstances, cannot provide individualized suspicion of criminal activity when hundreds of thousands of Pennsylvanians can lawfully produce that odor. What it does provide to police is a general, probabilistic

suspicion of criminal activity based on the fact that most citizens cannot legally consume marijuana. Thus, it is a factor that can contribute to a finding of probable cause, consistent with prior precedent . . . assuming some other circumstances supply more individualized suspicion that the activity is criminal.

Barr, 240 A.3d at 1287 (quotations omitted). The Court maintained it announced no new standard for probable cause with its holding, reasoning that

[t]he general illegality of marijuana under the CSA cannot simply be ignored merely because it is lawfully used in limited circumstances under the MMA and, thus, we must reject the trial court's conclusion that the odor of marijuana provides no indication of criminal activity. At the same time, those who act in compliance with the MMA should not be subjected to searches based solely on a generalized suspicion that is provided by that odor when the 4th Amendment also requires particularized suspicion.

Id.

Turning to the case sub judice, this Court finds that we may not apply Barr directly to the facts of this matter because the main issue in Barr concerns probable cause for a warrantless search and the issue here concerns probable cause for warrantless arrest. Nonetheless, the Court finds the rationale and reasoning in Barr to be relevant and instructive, especially in light of the fact that Barr represents the highest Pennsylvania court to address the MMA's effect on the legal analysis for warrantless police action when the odor of marijuana is detected during a traffic stop.<sup>9</sup>

On brief, the Defendant states that "if an odor of marijuana does provide probable cause for a search, then it also provides reasonable suspicion for detention and questioning, which would render [Defendant's] instant motion without merit." This interpretation of the plain smell doctrine, however, echoes the misconception discussed in Barr, where the Superior Court clarified that the plain smell doctrine has never stood as a per se rule that the odor of marijuana alone constitutes probable cause to believe criminal activity is afoot. The matter is simply not as black and white as the Defense frames it since "probable cause is a practical, nontechnical conception: it is a fluid concept turning on the assessment of probabilities in particular factual contexts not readily, or even usefully, reduced to a neat set of legal rules." Commonwealth v. Glass, 562 Pa. 187, 754 A.2d 655, 663 (2000) (cleaned up). In order to determine whether a constitutional violation has occurred under the totality of the circumstances, this Court may and indeed must consider other existing facts known to the police officer at the time, in addition to the odor of marijuana. See Barr, 240 A.3d at 1287.

While this Court is mindful that the Supreme Court has granted limited allocatur in Barr, the Superior Court's holdings are controlling until the Supreme Court renders a decision.

As previously stated, the Defendant does not challenge the validity of the initial traffic stop, the warrantless search of her car, or the investigative detention for administration of the SFSTs. 10 See supra notes 3, 5. Therefore, the Court need only determine if Defendant's constitutional rights were violated by the warrantless arrest made just prior to Defendant's removal from the scene for chemical testing. The unique facts in this matter are governed by two statutes, each with different standards for the level of suspicion required for lawful police action. First, the implied consent statute requires a police officer to have "reasonable grounds" to believe an individual has been driving a vehicle in violation of 75 Pa. C.S.A. §3802 (relating to driving under the influence of alcohol or a controlled substance) before that individual may be detained for chemical testing. The statute governing warrantless arrests in traffic stops, however, requires an officer to have the more stringent "probable cause to believe that the individual has violated . . . § 3802." 75 Pa. C.S.A. §3811. Trooper Artale's Report sets forth a timeline of events for the traffic stop that shows he placed Defendant under arrest after the SFSTs but before transporting her for chemical testing. The warrantless arrest coming first, the Court will evaluate this matter under the standard in §3811 and determine whether the totality of the circumstances at that point amounted to probable cause.

The Report shows Trooper Artale's decision to arrest the Defendant was based on far more than just the odor of marijuana he smelled emanating from Defendant's vehicle. The Report reflects that Artale considered the following factors prior to arresting the Defendant at the scene: 1) Defendant was speeding; 11 2) Trooper Artale detected the smell of burnt marijuana emanating from the passenger compartment of the vehicle; 3) Defendant's eyes were glassy and bloodshot; 4) Defendant appeared disheveled; 5) Defendant stated she had smoked marijuana approximately one-two hours prior to being stopped; and 6) Trooper Artale administered several SFSTs and determined that Defendant showed signs of impairment.12 Taking into consideration the analysis in Barr, the diminished significance of the odor of burnt marijuana post-MMA, and other existing precedent, the Court finds that the facts available Trooper Artale at the time of arrest did indeed constitute probable cause. Therefore, the Defendant was lawfully detained and transported for chemical testing.

#### IV. CONCLUSION

For the reasons set forth above, the Court finds that probable cause existed for Trooper Artale to arrest the Defendant, and the Omnibus Pretrial Motion to suppress the results of the chemical testing will be denied. Accordingly, I enter the following:

In Defendant's Brief in Support, she phrases the question presented as, "[w]hether detention and chemical testing of Defendant should be suppressed as there were not sufficient reasonable grounds." This statement indicates that Defendant initially questioned both the detention for SFSTs and the continued detention for chemical testing. Throughout the brief, however, Defendant only addresses the detention for chemical testing, concluding that the "detention for chemical testing and its results must be suppressed." See Def. Br. in Supp. at 2-7 (unpaginated).

11 The Defendant concedes that "unsafe driving could be a basis for reasonable grounds" for detaining the Defendant. He then argues that Defendant's excess speed (10 MPH over the speed limit) should not be considered a significant factor. This argument is without merit.
