Driver's license suspension appeal – Refusal of alcohol testing – Testing request in different county than where driving occurred

- The fact that one was treated for injuries in another jurisdiction immediately after an accident which occurred in Pennsylvania is irrelevant as to the issue of whether a Pennsylvania law enforcement officer retains authority to secure blood/alcohol test results from a driver suspected of driving under the influence of alcohol in Pennsylvania.
- 2. In this case, the officer on the scene observed in North Coventry Township, Chester County, that a single-vehicle accident had occurred; the driver was having difficulty shifting the car in park; had bloodshot and glassy eyes; slightly slurred speech; delayed responses; admitted to drinking; an odor of alcoholic beverages emanating from him; was very unsteady on his feet; was emotional and agitated and spoke of topics not being discussed; etc. Emergency medical personnel transported the driver to West Reading Hospital, outside of Chester County. Based upon the above law, this Court <u>Held</u> the second officer from the jurisdiction where the accident occurred and observations were made was authorized to seek blood outside of Chester County. Accordingly, this Court dismissed the license suspension appeal challenging the suspension for refusing chemical testing and suggested this Court's judgment should be affirmed by the Commonwealth Court of Pennsylvania.

OPINION PURSUANT TO Pa.R.A.P. 1925

Appellant, Robert E. Markle appeals from an order of the Court of Common Pleas of Chester County entered following a Summary Appeal hearing on August 23, 2023. Appellant argues that the officer was without jurisdiction to obtain implied consent from Appellant. This court respectfully disagrees. For the following reasons, this court's judgment should be affirmed.

BACKGROUND

On August 24, 2022, at approximately 6:15 PM, officers from North Coventry Police Department were dispatched to a single-vehicle crash on the ramp from South Hanover Street to 422 Eastbound. This location is in the confines of North Coventry Township, Chester County. See N.T., 8/23/2023, p. 5. Upon arrival at this location, Officer Victoria Hipple observed a white F-250 off the side of the road "kind of down an embankment... trapped in between a bunch of trees and brush and [the vehicle] was disabled." Id. at p. 5, 6. No other vehicles were on the scene of the crash. Id. at p. 6. Officer Hipple observed the driver, Robert E. Markle, attempting to reverse the vehicle back onto the main road. Id. at p. 5-6. Officer Hipple observed the taillights were active, the reverse lights were on, and the vehicle's engine was revving. Id. Therefore, Officer Hipple ordered Appellant to shift the vehicle to park, but Appellant continued to try to reverse the vehicle back onto the road and then shift the vehicle to the drive position. Id. At this point, Officer Hipple again instructed Appellant to shift the vehicle to park and Appellant eventually complied. Id.

However, after making contact with the Appellant, Officer Hipple observed that the vehicle was still in the reverse position. *Id. at p. 7*. Officer Hipple also observed that Appellant's responses were delayed. *Id.* She testified that when she asked Appellant to again place the vehicle in park, Appellant instead shifted the vehicle to drive and "kind of sat there and was on his phone scrolling through...." *Id.* After instructing Appellant

to again shift the vehicle to park, Appellant stated that the vehicle was in the park position but eventually shifted to park and continued to scroll on his phone. *Id*.

Appellant stated to Officer Hipple that he was not hurt, and that he was calling his friend to pull him out of the trees. *Id.* Appellant also stated that his steering was broke and that he was coming from an AA meeting. *Id.* Furthermore, he stated that "he can provide phone numbers from retired officers and a judge." **Id.** Officer Hipple testified that Appellant "tried to give us phone numbers and tried to make us call people while he was still seated in the vehicle, because he could not get out due to the door being pinned by the brush." *Id.*

While at the crash scene in North Coventry, Chester County, Officer Hipple asked if Appellant had anything to drink, to which he stated that he had not. *Id.* Officer Hipple testified that she did not believe the Appellant. *Id. at p. 8*. During her initial interaction with Appellant, Officer Hipple observed that the Appellant's eyes were "blood shot and glassy." *Id.* However, the Appellant stated he was not injured. *Id.* Officer Hipple also observed Appellant's speech was slightly slurred and his responses were delayed. *Id.* Additionally, while Appellant was talking with the emergency medical personnel on the scene, Appellant admitted to drinking at least one beer. *Id.* Officer Hipple witnessed the conversation between Appellant and the medic.

Officer Hipple explained that she assisted the on-scene medical personnel in escorting Appellant to the ambulance. She observed Appellant was "very unsteady on his feet" to the point where "[they] had to basically hold [Appellant] up and direct him where to go." *Id. at p. 9.* Furthermore, she testified that the terrain was not impassable and was definitely walkable for a normal person. *Id.* However, as Appellant and medic arrived at the ambulance, Appellant stumbled up the stairs and then into the ambulance. *Id.* Officer Hipple testified that Appellant ultimately fell over onto the stretcher. *Id.*

While evaluating the Appellant, Officer Hipple testified that she continued to talk with Appellant in the ambulance. *Id.* During this conversation, Officer Hipple testified that she detected "a moderate odor of alcoholic beverages emanating from [Appellant] while speaking with [Appellant]. *Id.* Moreover, she observed that Appellant's emotions were both high and low: "[h]e would cry and say that, you know, he had quit drinking, he had gone to AA. And then if the medical personnel asked him a question, he would stop crying and answer the question and then go back into crying again and saying, you know, I quit drinking, I don't need this right now." *Id.*

Office Hipple testified that when the medics informed the Appellant that he would not be released but instead taken to the hospital, she observed the Appellant became agitated. *Id.* Appellant indicated that he did not want to go to the hospital and continued to refer to his deceased son, stating that "[Officer Hipple] had been there... that we had found him dead... and he just kept repeating himself over and over!." *Id. at p. 10.* Additionally, Appellant asked for favors saying "hey, just do me this favor." *Id.* While in the ambulance, Officer Hipple also observed that Appellant was very delayed in answering questions and was abnormal by "referring back to things that we weren't talking about." *Id.*

Officer Hipple testified that she did not perform any field sobriety test on Appellant. *Id. at p. 16*. However, Officer Hipple did ask Appellant to submit to a field sobriety test if Appellant did not go to the hospital. *Id.* Appellant asked for Officer Hipple's advice. Officer Hipple explained that she could not give Appellant advice on the issue. *Id.* Appellant never responded to Officer Hipple's question concerning submitting to field sobriety tests. *Id.* Ultimately, the emergency medical personnel determined that Appellant would not be medically cleared to refuse so he would have to go to the hospital. *Id.*

Appellant was then transported to West Reading Hospital. Although Officer Hipple believed that Appellant was under the influence of alcohol and/or a controlled substance to the point where he was unfit to drive, she was at the end of her shift. *Id. at p. 11*. Accordingly, Officer Hipple requested that the oncoming officer follow the ambulance to West Reading Hospital to perform a chemical test on Appellant. *Id.*

The oncoming officer was Officer Andrew Thiel who followed the ambulance to West Reading Hospital. While at the hospital, Officer Thiel read the PennDot DL-26 form which advises a licensee of their rights regarding refusing a chemical test. This court observed Officer Thiel read the DL-26 Form verbatim, in its entirety, to Appellant while Appellant was sitting in a hospital bed. *See Exhibit C-2*. Additionally, this court observed the Appellant refuse to consent to the blood draw. *Id.* Moreover, Appellant signed the DL-26 Form, refusing the chemical test. *See Exhibit C-1*.

Based upon the record, this court dismissed Appellant's statutory appeal of the suspension of his operating privilege by the Pennsylvania Department of Transportation, Bureau of Driver Licensing ("PennDOT"), which the PennDOT imposed pursuant to Section 1547(b)(1)(i) of the Vehicle Code, 75 Pa. C.S. § 1547(b) (1)(i), commonly referred to as the Implied Consent Law, after Licensee refused chemical testing.

Appellant filed a timely appeal to the Commonwealth Court of Pennsylvania on August 31, 2023. This court directed Appellant to file a Concise Statement of Errors Complained of on Appeal ("Concise Statement"). On September 16, 2023, Appellant timely complied and filed a Concise Statement, arguing that Officer Thiel exercised unauthorized police activity outside of Chester County.

DISCUSSION

Crash and Corresponding Investigation Occurred in Primary Jurisdiction

Officer Hipple testified that she responded to a one vehicle crash at the ramp from South Hanover Street and U.S. Route 422 eastbound located within the confines of North Coventry, Chester County. Upon her arrival to that scene, she observed the Appellant, and sole occupant of the vehicle, trying to back up. Appellant's eyes were "blood shot and glassy," his speech was slightly slurred, and his responses were delayed. Officer Hipple also observed Appellant admit to the emergency medical personnel at the crash scene to drinking at least one beer. In the ambulance on the

scene of the crash, Officer Hipple detected "a moderate odor of alcoholic beverages emanating from [Appellant] while he was speaking."

Furthermore, while Appellant indicated that he was not injured, Officer Hipple observed that he was "very unsteady on his feet" to the point where "[they] had to basically hold [Appellant] up and direct him where to go." Yet, she noted that the terrain was walkable for a normal person but not for the Appellant. Officer Hipple also observed Appellant stumbled up the stairs and then into the ambulance, where Appellant ultimately fell over onto the stretcher.

Finally, Officer Hipple also observed Appellant's emotions as being both high and low, where he would cry and say that.... he had quit drinking; he had gone to AA; how Appellant should have been there for his deceased son. Based on the totality of the circumstances observed by Officer Hipple at the scene in North Coventry, she determined that Appellant was unfit to drive due to alcohol or drug impairment. She conducted her investigation in North Coventry at the crash scene and in the ambulance situated there. While acting in her official capacity, she developed the requisite probable cause to arrest the Appellant under suspicion of D.U.I. while at the scene of the crash in North Coventry.

Because her shift was ending and the Appellant was being transported to the hospital by and at the direction of the emergency medical providers, she directed Officer Theil of the North Coventry Police Department to follow the ambulance to the hospital. Based on Officer Hipple's assessment the Implied Consent Law was implicated. Once at the hospital, Officer Theil advised the Appellant of the Implied Consent Law. The Appellant refused to comply.

This court relied on the holding in *Commonwealth v. Stair*, 548 Pa. 596 (Pa. 1997) in determining that the North Coventry Police were within their authority in the instant matter. In *Stair*, a Pennsylvania State Trooper had reasonable grounds to believe the Appellant was operating his vehicle while under the influence of alcohol. The Appellant, Kevin Scott Stair, was transported from the scene of the accident in Bedford, Pennsylvania to a nearby hospital in Maryland. In that case, the Appellant claimed that the Pennsylvania State Trooper did not have jurisdiction to advise the Appellant of the Implied Consent Law at the Maryland hospital. However, Justice Cappy opined:

"the fact that Appellant was treated for his injuries in another jurisdiction immediately after an accident which occurred in Pennsylvania is irrelevant as to the issue of whether a Pennsylvania law enforcement officer retains section 1547(a) authority to secure BAC test results from a driver suspected of driving under the influence of alcohol in Pennsylvania. If reasonable grounds exist for the Pennsylvania police officer to believe that a driver was operating a vehicle while under the influence of alcohol in Pennsylvania, the requirements of section 1547(a) are met, and the officer may proceed to secure BAC test results, provided, of course, that he also complies with the dictates of section 1547(b)...." *Id. at 604*.

Justice Cappy explained that the trooper's reading of the Implied Consent Law to the Appellant at the hospital "was merely a fulfillment of an administrative act necessitated by the Pennsylvania Implied Consent Law." *Id. at 607*.

CONCLUSION

Pursuant to 75 Pa. C.S. § 1547, this court finds that Officer Thiel was authorized to engage in the administrative act of reading the Implied Consent Law to the Appellant at the hospital where he was taken even though it was outside of North Coventry, Chester County. Therefore, for the reasons set forth above, this court judgement should be affirmed.
