## Winters v. Patient First Pennsylvania Medical Group, et al.

Preliminary objections - Standing - Demurrer - Certificate of merit - Vicarious liability

- 1. Standing requires a party to have a substantial interest in the subject matter of the litigation; the interest must be direct; and the interest must be immediate and not a remote consequence.
- 2. A demurrer is an assertion that a complaint does not set forth a cause of action on which relief may be granted.
- 3. A pharmacist is unauthorized to supply a written statement opining that a physician's conduct failed to meet the standard of care.
- 4. No person shall be competent to offer an expert medical opinion in a medical professional liability action against a physician unless that person possesses an unrestricted physician's license to practice medicine.
- 5. An exception may apply allowing a non-physician to opine as to medical or scientific issues including (a) risks and alternatives, (b) causation, and (c) the nature and extent of the injury, but the exception does not allow a non-physician to opine as to the standard of care.
- 6. A Certificate of Merit as to a medical group is defective if there is no proper underlying certificate of merit to support Plaintiff's claim of vicarious liability.
- 7. In the Complaint, Plaintiff alleged a doctor negligently prescribed Paxil for Plaintiff's minor daughter causing harm to Plaintiff's relationship with his daughter, etc. Defendants filed Preliminary Objections, including a Motion to Dismiss Based on Plaintiff's Lack of Standing and a Motion to Strike Certificates of Merit. Defendants acknowledge that Plaintiff is trying to claim damages for himself based on the alleged medical malpractice committed against his daughter and fail to explain why Plaintiff would lack standing to bring claims on his own behalf. The Court <u>Held</u> Defendants' Motion to Dismiss Based on Plaintiff's Lack of Standing was denied; Defendants' Motion to Strike Certificates of Merit was granted; and the Prothonotary was directed to seal page 3 of the Complaint because it contains minors' names which are confidential information.

## **ORDER and MEMORANDUM**

**AND NOW**, this 21st day of November, 2024, upon consideration of Defendants' Preliminary Objections to Plaintiff's Complaint filed July 18, 2024 and Plaintiff's response thereto, for the reasons set forth in the accompanying Memorandum it is hereby **ORDERED** as follows:

1. Defendants' Motion to Dismiss Based on Plaintiff's Lack of Standing is **DENIED** and Defendants shall file an Answer to Plaintiff's Complaint no later than twenty (20) days from the entry of this order; and

2. Defendants' Motion to Strike Certificate[s] of Merit is **GRANTED** and the certificates of merit filed June 28, 2024 are **STRICKEN** with leave granted to Plaintiff to file proper certificates of merit no later than twenty (20) days from the entry of this order.

**IT IS FURTHER ORDERED** that the Prothonotary shall **SEAL** page three (3) of Plaintiff's Complaint filed April 30, 2024 which contains minors' names which are confidential information prohibited by Section 7.0 of the Case Records Public Access Policy of the Unified Judicial System of Pennsylvania (Policy) and are in violation of Pa.R.Civ.P. 205.6 (Confidential Information and Confidential Documents. Certification).

**IT IS FURTHER ORDERED** that all legal papers shall be filed in accordance with the Policy and Pa.R.Civ. 205.6.

### **MEMORANDUM**

On April 30, 2024, Plaintiff filed a Complaint alleging that Paul J. Wilson, D.O. negligently prescribed Paxil for Plaintiff's minor daughter causing harm to Plaintiff as follows: (1) injury to Plaintiff's relationship with his daughter; (2) loss of Plaintiff's right to legal and physical custody of his daughter; (3) medical expense; (4) pain and suffering; and (5) future loss of earnings. *See* Complaint, 4/30/2024, ¶ 21, 24, 27-28.

On July 18, 2024, all Defendants together filed Defendants' Preliminary Objections to Plaintiff's Complaint which are presently before this court. More specifically, Defendants presented a Motion to Dismiss Based on Plaintiff's Lack of Standing, Preliminary Objections, 7/18/2024, ¶¶ 5-17, and a Motion to Strike Certificate[s] of Merit, Preliminary Objections, 7/18/2024, ¶¶ 18-22.

This court finds no merit in Defendants' Motion to Dismiss Based on Plaintiff's Lack of Standing. "Standing requires a party to have a substantial interest in the subject matter of the litigation; the interest must be direct; and the interest must be immediate and not a remote consequence." In re Raymond G. Perelman Charitable Remainder Unitrust, 113 A.3d 296, 302 (Pa.Super. 2015) (quoting Rock v. Pyle, 720 A.2d 137, 142 (Pa. Super. 1998)), *appeal denied* 131 A.3d 492 (Pa. 2016). Here, Defendants acknowledge that "Plaintiff is not attempting to bring [a] cause of action on behalf of his daughter, [but] rather trying to claim damages for himself based on the alleged medical malpractice committed against his daughter." Preliminary Objections, 7/18/2024, ¶ 10. Defendants fail to explain why Plaintiff would lack standing to bring claims on his own behalf, Brief, 7/18/2024, pp. 2-3, and Defendants' objection to Plaintiff's standing is no substitute for a properly presented demurrer. *See* Stilp v. Governor of Pennsylvania, 699 A.2d 1353 (Pa. Cmwlth. 1997) ("A demurrer is an assertion that a complaint does not set forth a cause of action on which relief may be granted.") (citing David v. Secretary of Public Welfare, 598 A.2d 642 (Pa.Cmwlth. 1991)).

This court finds merit in Defendants' Motion to Strike Certificate[s] of Merit. Defendants argue that Plaintiff's supporting written statements (as required by Pa.R.Civ.P. 1042.3(e)) are supplied by Kristen Jonas, PharmD, who is a licensed pharmacist and "not a physician, and therefore unable to comment on the appropriate standard of care of physicians." Preliminary Objections, 7/18/2024, ¶ 20. This court agrees. A pharmacist is unauthorized to supply a written statement opining that a physician's conduct failed to meet the standard of care. Pa.R.Civ.P. 1042.3(a)(1) (note) ("in a medical professional liability action against a physician, the expert who provides the statement in support of a certificate of merit should meet the qualifications set forth in Section 512 of the Medical Care Availability and Reduction of Error (MCARE) Act, 40 P.S. § 1303.512(a)-(b)(1) ("No person shall be competent to offer an expert medical opinion in a medical professional liability action against a physician's license to practice medicine in any state or the District of Columbia.").<sup>1</sup></sup>

<sup>&</sup>lt;sup>1</sup> An exception may apply allowing a non-physician to opine as to medical or scientific issues including (1) risks and alternatives, (2) causation, and (3) the nature and extent of the injury, but the exception does not allow a non-physician to opine as to the standard of care. 40 P.S. § 1303.512(b).

## 57CHESTER COUNTY REPORTSWinters v. Patient First Pennsylvania Medical Group, et al.54 (2025)

Here, the Certificate of Merit as to Paul J. Wilson, D.O. filed June 28, 2024 is defective because the written statement was supplied by a pharmacist, not a physician. The Certificate of Merit as to Olga Vinshtok, M.D. filed June 28, 2024 is defective because the written statement was supplied by a pharmacist, not a physician. The Certificate of Merit as to Patient First Pennsylvania Medical Group, PLLC filed June 28, 2024 is defective because there is no proper underlying certificate of merit to support Plaintiff's claim of vicarious liability and "A certificate of merit, based on the statement of an appropriate licensed professional required by subdivision (a)(1), must be filed as to the other licensed professionals for whom the defendant is responsible." Pa.R.Civ.P. 1042.3(a)(2) (note).

Accordingly, this court will enter an order consistent with the foregoing.
