

York, PA – December 5, 2011 – Bradley C. Jacobs, York County Register of Wills & Clerk of Orphans' Court, is pleased to announce a new service offering for professionals. Beginning in January 2012 attorneys will be able to request access to <u>estate</u> document images online.

Currently, attorneys have the ability to request permission to access estate files online; however, document images are not available. Jacobs has decided to enhance this access by allowing attorneys to view and print document images.

"It is important for us to serve our professionals and felt that access to document images from the privacy of their office or homes would save the attorneys time" Jacobs said. "We truly value the relationship we have with our attorneys and look forward to providing this service to them."


