APPROVAL OF RESOLUTION OF INTENT

WHEREAS, pursuant to 53 Pa.C.S. §5601-§5622 of the Municipality Authorities Act, the Commonwealth of Pennsylvania allows its municipalities to create authorities; and

WHEREAS, the Greene County Board of Commissioners (the "Board") is considering the creation of a General Authority in order to enhance services and to develop and facilitate the development of County owned or controlled real property and to better serve the residents, businesses and prospective businesses seeking to locate in Greene County; and

WHEREAS, pursuant to 53 Pa.C.S. §5603(a), whenever the municipal authorities of any municipality singly or of two (2) or more municipalities jointly desire to organize an authority under this chapter, they shall adopt a resolution or ordinance signifying their intention to do so; and

WHEREAS, no such resolution or ordinance shall be adopted until after a public hearing has been held, the notice of which shall be given at least thirty (30) days before the hearing; and

WHEREAS, notice of such resolution or ordinance is to be published at least one (1) time in the legal periodical of the county or counties in which the authority is to be organized and at least one (1) time in a newspaper published and in general circulation in such county or counties; and

WHEREAS, the Board recognizes the necessity for the continuance of coordinated and cooperative planning with community partners and will continue to seek public input with respect to such developments.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF GREENE, STATE OF PENNSYLVANIA:

THAT, the Board has the intention of filing the Articles of Incorporation necessary for the creation of a municipal authority known as the Greene County General Authority; and

THAT, a public hearing to consider the adoption of resolutions authorizing the creation of such municipal authority be scheduled for the 10th day of October, 2024 at 11:00 o'clock in the Greene County Office Building; and

THAT, pursuant to 53 Pa.C.S. § 5603(a) proper public notice be provided as required by law for the public hearing before the Board; and

THAT, officers and employees of Greene County are authorized and directed to take all actions necessary or appropriate to effectuate the provisions of this resolution; and

THAT, the Board determines and declares that this resolution is necessary for the welfare and benefit of the citizens of Greene County.
