### OPINION AND ORDER

VERNON, J.

February 3, 2025

Before the Court is the Petition for Writ of Habeas Corpus filed by Defendant, Thomas Edward Wiencek, contending that the Commonwealth cannot establish a prima facie case as to the mens rea of recklessness or gross negligence to support the charges of homicide by vehicle, aggravated assault by vehicle, involuntary manslaughter, and recklessly endangering another person.

At the time set for hearing, the Commonwealth presented the testimony of Trooper Michael Parlak of the Pennsylvania State Police who testified that on the early afternoon of August 16, 2021, he was dispatched to a traffic collision at the intersection of State Route 31 and Pleasant Valley Road, Bullskin Township. Upon his arrival, Trooper Parlak noted a Peterbilt Tri-Axle entangled with a Ford Focus. Trooper Parlak identified Defendant as the operator of the tri-axle truck and Lee Welker as the operator of the Ford Focus with his wife, Diane Welker, as a passenger. At the scene, Trooper Parlak spoke with Defendant who stated, "that he must not have been paying attention; when he came to the intersection, he thought the light was green and then he struck the victims' vehicle at the intersection." Defendant further told Trooper Parlak that he attempted to stop but was unable to do so. An eyewitness, Blane Morrison, told Trooper Parlak that he was positioned directly behind Defendant's truck and that the light was red when Defendant proceeded through the intersection striking the victims' car.

Pennsylvania State Police Trooper Jason Hatalsky was recognized as an expert in the field of accident reconstruction and performed a collision analysis. The collision was captured on the security camera of Speedy Meedys. The collision analysis revealed that Defendant's tri-axle truck did not stop at a steady red light. The footage showed that the light was red for fifteen to twenty seconds for Defendant's lane of travel. Neither weather conditions nor topography played a factor in the collision. The collision occurred in daylight, with clear visibility, and no adverse condition. The collision analysis further revealed no evidence of speeding, erratic driving, cell phone usage, driver impairment, or vehicle malfunction.

To prove the offenses of homicide by vehicle, aggravated assault by vehicle, and involuntary manslaughter, the Commonwealth must prove beyond a reasonable doubt that "a defendant's conduct was either reckless or grossly negligent." Commonwealth v.

Wyatt, 203 A.3d 1115 (Pa. Super. 2019). The state of mind of gross negligence under the aggravated assault by vehicle and homicide by vehicle statutes is the same as recklessness. Wyatt, 203 A.3d at 1118.

The Crimes Code defines recklessness as follows:

A person acts recklessly with respect to a material element of an offense when he consciously disregards a substantial and unjustifiable risk that the material element exists or will result from his conduct. The risk must be of such a nature and degree that, considering the nature and intent of the actor's conduct and the circumstances known to him, its disregard involves a gross deviation from the standard of conduct that a reasonable person would observe in the actor's situation.

18 Pa.C.S.A. § 302(b)(3).

Recklessness requires proof that the defendant both had actual knowledge of a substantial and unjustifiable risk and disregarded that risk despite that knowledge. Commonwealth v. Sitler, 144 A.3d 156, 164 (Pa. Super. 2016).

Recklessness "implicates knowledge in two ways: (1) the actor must consciously (i.e., with knowledge) disregard a substantial and unjustifiable risk; and (2) the risk that the actor disregards is measured by the circumstances known to the actor." "Conscious disregard" of a risk, in turn, "involves first becoming aware of the risk and then choosing to proceed in spite of the risk." Commonwealth v. Fretts, 271 A.3d 383, 389 (Pa. Super. 2021).

In Commonwealth v. Sanders, 259 A.3d 524, 533 (Pa. Super. 2021), a bus driver was on a new route when she stopped at a red light to check paperwork to confirm the correct way to go. In making a left turn, she struck and killed a 93-year-old pedestrian who was properly crossing the street in a crosswalk. The Superior Court vacated the bus driver's homicide by vehicle conviction on the ground that the evidence was insufficient to permit a finding of recklessness where the bus driver made the turn on a green light traveling at 8 miles an hour and looked before turning and there was no evidence that the bus driver could see the pedestrian when she looked to her left. Id. 259 A.3d at 530, 532–35. The Court, moreover, held that the bus driver's conduct could not be found to be reckless, even though the pedestrian was visible for forty-five seconds while the bus was stopped for a red light at the intersection and the driver could have seen him if she had looked while waiting for the light to turn green, rather than looking at work papers, and even though she violated several work rules, including steering the bus with one hand and failing to wait a full 4 seconds before making a left turn. Id. 259 A.3d at 532–35.

In its examination of recklessness in Sanders, the Superior Court opined, "[h]ad Appellant's bus barreled through the red light without stopping, that would have been a conscious disregard of a substantial and unjustifiable risk, the essence of recklessness." Id. 259 A.3d at 533. This exact hypothetical occurred here. Defendant evidenced a conscious disregard of the substantial and unjustified risk that he would be involved in a traffic accident causing death when his triaxle "barreled" through a red light colliding with the vehicle of Lee Welker and his wife, Diane Welker.

WHEREFORE, we will enter the following ORDER denying the Petition for Writ of Habeas Corpus

### ORDER

AND NOW, this 3rd day of February, 2025, upon consideration of the Petition for Writ of Habeas Corpus filed by Defendant, Thomas Edward Wiencek, and in accordance with the foregoing Opinion, it is hereby ORDERED and DECREED that the Petition is DENIED.
