# MEMORIAL RESOLUTION OF THE CARBON COUNTY BAR ASSOCIATION

The Court of Common Pleas of Carbon County and the members of the Carbon County Bar Association have convened upon this sad occasion to honor and pay tribute to a friend and colleague, the Honorable Richard W. Webb, to inscribe this Resolution upon the minutes of the Bar Association and the docket of the Court of Common Pleas of Carbon County as a memorial to his memory, to express our appreciation for his years of service to the legal community, to record an acknowledgment of the privilege that was ours in being associated with him in the course of his highly distinguished legal and judicial career and to express our sorrow for the loss which the Bench and Bar have sustained.

Richard W. Webb was born in Palmerton, Pennsylvania, on April 29, 1944, the son of the late Sidney and Ellen Webb. A lifetime resident of Palmerton, Judge Webb received his early education in the Palmerton public school system. After earning a degree at his beloved Pennsylvania State University in 1966, he went on to the University of Pittsburgh Law School where he was awarded a Juris Doctor Degree in 1969. Following graduation from law school, Judge Webb worked briefly for Arthur Anderson in Pittsburgh. He then returned to Palmerton where he practiced law with his father before embarking on his career in public service.

From 1973 to 1975 he served as a public defender. In November of 1975 he won election to the office of District Attorney, an office which he held for 16 years. During those years he established an outstanding reputation for integrity, diligence, ability and as a fierce courtroom prosecutor. During his tenure as District Attorney, Judge Webb founded the Carbon County Drug Task Force and received many awards and citations for his tenacious prosecution of drug cases.

Judge Webb became Carbon County's 15th judge when he was sworn in on January 6, 1992. He became President Judge on February 18, 2001, upon the retirement of President Judge John P. Lavelle. In November of 2001 he was elected to a second 10-year term, com-

mencing January 7, 2002. He took early retirement in 2004 but continued to serve Carbon County as a Senior Judge handling various types of cases.

Needless to say, Judge Webb made great contributions to the judicial system of Carbon County. He was compassionate, well prepared and had an outstanding judicial temperament. He had total control of the courtroom with his personality. He loved the law and served it well.

Judge Webb passed away on August 20, 2016. He is survived by his wife, Janet; son, Richard and his wife Sue Ann, with grandchildren Sidney, Gavin and Leah; son, Thomas and wife Angela, with granddaughter Francesca.
