ORDER

AND NOW, this 17th day of March 2020, in accordance with the Order of the Supreme Court of Pennsylvania, declaring a general, statewide, judicial emergency, *see* 532 Judicial Administration Docket (Mar. 16, 2020), the following is hereby ORDERED:

- A. The public counters for all three Superior Court Offices of the Prothonotary are CLOSED until further Order of this Court. The Court will continue to accept filings ONLY through PACFile electronic filing, through the United States Postal Service, or by commercial delivery carrier.
- B. The due dates for all filings due in the Superior Court between March 17, 2020, and April 17, 2020, are EXTENDED by 30 days. Filings for matters classified as Children's Fast Track, see Pa.R.A.P. 102 (r:elating to definitions), are NOT SUBJECT to this extension;
- C. All timelines imposed by Pennsylvania Rule of Appellate Procedure 903, for appeals from orders entered between March 17, 2020, and April 17, 2020, that would be subject to the Superior Court's jurisdiction, are EXTENDED by 30 days. The courts of common pleas are directed to ensure all notices of appeals filed in their courts bear a date stamp of the court's receipt of the notice of appeal, and that each notice of appeal either bears an electronic-filing stamp or is attached to the postmark from the envelope that contained the notice of appeal. Notices of appeal in matters classified as Children's Fast Track, see Pa.R.A.P. 102 (relating to definitions), are NOT SUBJECT to this extension;
- D. The due dates for applications for reconsideration or reargument, as imposed by Pennsylvania Rule of Appellate Procedure 2542(a), are EXTENDED by 30 days. The due dates for applications for reconsideration or reargument of Children's Fast Track cases, as imposed by Pennsylvania Rule of Appellate Procedure 2542(b), are NOT SUBJECT to this extension;
- E. Any requests for extensions of time or other extraordinary relief related to applications filed pursuant to the Wiretapping and Electronic Surveillance

Control Act, 18 Pa.C.S. §§ 5701, et seq. ("Wiretap Act") shall be made to the judge who has been assigned to the particular wiretap application or, if the wiretap application has not yet been assigned, then to the Wiretap Act Supervising Judge.

The time limits for any order authorizing the interception of any wire, electronic or oral communication as set forth in § 5712(b) of the Wiretap Act shall remain in full force and effect; AND

F. All emergency motions shall be filed through the PACFile electronic filing system, and must be clearly titled as an Emergency Motion. To the extent a party is unable to file an emergency motion on PACFile, they are encouraged to call the respective district's Prothonotary's Office, which phone numbers may be found at:

http://www.pacourts.us/courts/superior-court/prothonotarys-addresses. Parties are on notice that emergency motions may take longer than usual to address.

Children's Fast Track filings must be made within the time established by general rule using the PACFile electronic filing system, *see* Pa.R.A.P. 125 (relating to electronic filing), or by proper postmark or receipt as provided by the United States Postal Service or commercial delivery carrier.

Any future Orders regarding Superior Court operations during the COVID-19 situation shall be docketed at this Administration Docket number and posted on the Unified Judicial System website.

This Court's Prothonotary is DIRECTED to transmit this Order to the Pennsylvania Bar Association, with a request that such association promptly forward the notice to all members and all local bar associations.

This Order shall terminate on April 17, 2020, unless renewed on or before that date.

ADMINISTRATIVE ORDER-Additional Guidelines

AND NOW, to wit, this 18th day of March, 2020, per the Supreme Court's Order dated March 16,2020, the declaration of a Judicial Emergency in the 22nd Judicial District for the time period of March 16, 2020 through April 14, 2020, and the Administrative Order adopted on March 17,2020, the following also apply immediately until further Order of Court:

- Magisterial District Courts in Wayne County are closed to the public, until further Order of Court when safe operations of the Court and its offices can be restored, except for proceedings deemed to be emergencies by the presiding magisterial district judge, including, but not limited to:
 - a. Search Warrants;
 - b. Emergency Protection from Abuse actions;
 - c. Preliminary hearings and/or bail review hearings for incarcerated defendants.
- The Domestic Relations Office will be closed to the public from the close of business Wednesday, March 18, 2020 until further Order of Court when safe operations of the Court and its offices can be restored, and all new filings may be made online at www.humanservices.state.pa.us/csws.
- 3. The Adult and Juvenile Probation Offices will be available to handle Essential Functions as delineated by the March 17,2020 Administrative Order. Supervision services will use technological resources and the offices will otherwise be closed to the public from the close of business Wednesday, March 18, 2020 until further Order of Court when safe operations of the Court and its offices can be restored.

- 4. Payments of fines and costs in pending cases may be made online at https://ujsportal.pacourts.us/PayOnline.aspx.
- 5. All Sheriff sales from the period of March 25,2020 through and including April 22, 2020 are postponed for thirty (30) days.

WAYNE COUNTY MAN CHARGED WITH ESCAPE AND RESISTING ARREST

A 33-year old Damascus Township man threatened to shot himself after Wayne County Sheriff Deputies attempted to serve a bench warrant. Wayne County Detectives charged Timothy Todd Everard of 178 Baldwin Hill Road, Damascus PA with Escape, Flight, and Resisting Arrest, announced District Attorney A.G. Howell.

"I want to take this opportunity to thank the members of the Wayne County Sheriff's Department, Pennsylvania State Police, Wayne County Detectives, Honesdale

Borough Police Department, and the Pennsylvania Game Commission for not only working together to arrest Mr. Everard but also keeping our community safe as a whole during this difficult and complicated time."

On March 17, 2020, Wayne County Sheriff Deputies attempted to serve a bench warrant on Mr. Everard for his failure to appear for trial on March 16, 2020. Upon informing Mr. Everard about the bench warrant, he barricaded himself in a bedroom within the residence. Mr. Everard refused to leave the bedroom and threatened to shot himself. The Wayne County Sheriff Deputies then requested assistance from the Pennsylvania State Police, Wayne County

Detectives, Honesdale Borough Police Department, and the Pennsylvania Game Commission.

After multiple unsuccessful attempts were made for Mr. Everard to exit the bedroom, law enforcement opened the door with a ram to take Mr. Everard into custody without further incident.

Mr. Everard is charged with escape, flight to avoid apprehension, and resisting arrest. On March 19, 2020, he was arraigned before Magisterial District Judge Ronald Edwards and remanded to the Wayne County Correctional Facility in lieu of \$15,000.00 bail. Mr. Everard's bail on the other matter was revoked. Mr. Everard is scheduled to appear at central court on March 25, 2020.
