#### Palmer v. Palena

#### Preliminary injunction – Adverse possession

- A court may grant a preliminary injunction only where the moving party establishes the following elements: (a) the relief is necessary to prevent immediate and irreparable harm which cannot be compensated by damages; (b) greater injury will occur from refusing the injunction than from granting it; (c) the injunction will restore the parties to the status quo as it existed immediately before the alleged wrongful conduct; (d) the alleged wrong is manifest and the injunction is reasonably suited to abate it; and (e) the plaintiff's right to relief is clear.
- 2. The cause of action for adverse possession does not accrue until there is some unequivocal act, the knowledge of which is brought home to the other party, tending to show that the former holds adversely; otherwise, no issue of the statute of limitations can arise.
- A consentable boundary constitutes a clear-cut instance of adverse possession.
   It is a judicial recognition of a boundary, usually marked by a substantial fence that the parties have consensually accepted for the requisite period of time.
- 4. Establishing a prescriptive easement is very similar to that of adverse possession.
- 5. Permissive use defeats a claim of a prescriptive easement.
- 6. The Court noted the dispute arose August 28, 2020, but no intervention in court for injunctive relief was sought until April 27, 2021, so the requisite immediacy for a preliminary injunction was seemingly not shown; accordingly, the Court <u>Held</u> Plaintiff's Emergency Petition for Preliminary Injunctive Relief was denied.

#### ORDER

AND NOW, this 18th day of November, 2021, upon consideration of Plaintiff Kevin A. Palmer's Emergency Petition for Preliminary Injunctive Relief, Defendant Bryn Palena's Answer thereto, and after a hearing thereon, it is hereby ORDERED that the Petition is DENIED.<sup>1</sup>

A court may grant a preliminary injunction only where the moving party establishes the following familiar elements: (1) the relief is necessary to prevent immediate and irreparable harm which cannot be compensated by damages; (2) greater injury will occur from refusing the injunction than from granting it; (3) the injunction will restore the parties to the status quo as it existed immediately before the alleged wrong ful conduct; (4) the alleged wrong is manifest and the injunction is reasonably suited to abate it; and (5) the plaintiff's right to relief is clear. Summit Towne Ctr. v. Shoe Show of Rocky Mount, Inc., 573 Pa. 637, 647, 828 A.2d 995, 1001 (2003). The court was concerned that the requisite immediacy was not shown, insofar as the dispute arose August 28, 2020 but no intervention in court for injunctive relief was sought until April 27 of the following year – eight (8) months later.

More troubling was whether the plaintiff had established that he had a "clear right to relief." Plaintiff's underlying theory was that he had possession of the disputed piece of land that was actual, continuous, visible, notorious, distinct and hostile for the statutory period of time, now ten (10) years by an act passed in 2018. See 42 Pa. C.S.A. §5527.1. The evidence, however, showed no hostile act of any kind between these parties or their predecessors in title since at least plaintiff's purchase in 1990, a period exceeding thirty-one (31) years. See Plaintiff's Emergency Petition for Preliminary Injunctive Relief, ¶11. Where the parties holding legal title were unaware of the ownership and the parties in actual possession were likewise in ignorance of the record legal ownership, how can it be argued that there was any element of hostile possession until all the parties became aware of such legal ownership of the disputed land?

Although the word "hostile" has been held not to mean ill will or hostility, it does imply the intent to hold title against the record title holder. The act of hostility necessary to render possession adverse must be

"brought home" to the owner of the property as a condition precedent to its effectuation. Indeed, since there was no evidence in this case of any hostile act until August 28, 2020, adverse possession in this case never began to run until that time. *Klett v. Eboch*, 430 Pa. Super. 193, 633 A.2d 1204 (1993). In other words, the cause of action for adverse possession does not accrue until there is some unequivocal act, the knowledge of which is brought home to the other party, tending to show that the former holds adversely; otherwise, no issue of the statute of limitations can arise. *Id.* The ten (10) yearlong limitation in this case will ripen on August 28, 2030.

Other theories espoused by the Plaintiff are of no avail at this stage of the litigation.

A consentable boundary constitutes a clear-cut instance of adverse possession. It is a judicial recognition of a boundary, usually marked by a substantial fence that the parties have consensually accepted for the requisite period of time. *See, gen. Lilly v. Markvan*, 563 Pa. 553, 763 A.2d 370, n. 1 (2000).

Establishing a prescriptive easement is very similar to that of adverse possession. Permissive use defeats a claim of a prescriptive easement. *Morning Call, Inc. v. Bell Atlantic Pa., Inc.*, 761 A.2d 139, 143 (Pa. Super. 2000).

For these reasons, the court cannot grant the Emergency Petition for Preliminary Injunctive Relief.
