Expungement of record in Central Registry Depository – Rule absolute – Void judgment – Personal jurisdiction

- 1. The Chester County Rules of Civil Procedure provide that if no answer has been timely filed, the petitioning party, not less than five days after the rule return date, may move to have the rule made absolute, granting the prayer of the petition, and the Court may consider such petition as unopposed and grant such motion as of course.
- 2. A judgment is void when entered by a court lacking personal jurisdiction obtained pursuant to proper service of original process, waiver, or consent.
- 3. Petitioners filed a Petition for Entry of Expungement Order of Jeffrey Kitchen's Central Registry Depository record, alleging Financial Industry Regulatory Authority (FINRA) waived any requirement it be named as an additional party. The Sheriff served the person who alleged his funds had been mismanaged with the Petition, associated papers and a Rule to Show Cause, to which no response was filed. This Court noted the Petitioners were asking for an order directing FINRA to expunge when FINRA was not made a party to the action and had not been served. This Court <u>Held</u> Petitioner's Motion to Make Rule Absolute was denied, without prejudice, because granting the request would be void and a legal nullity as this Court lacked personal jurisdiction.

MEMORANDUM

On January 29, 2024, Petitioners commenced this action by filing a Petition for Entry of Expungement Order. Petitioners alleged that Michael D. Moses brought a claim before the Financial Industry Regulatory Authority (FINRA) against Edward D. Jones & Co., LP for mismanaging his investments, which claim was settled, but which claim remains on Jeffrey Kitchen's Central Registry Depository record. Petition, 1/29/2024, ¶ 1-2, 12-13, 15. Petitioners alleged that an arbitration panel recommended that FINRA expunge the claim from Jeffrey Kitchen's Central Registry Depository record but that FINRA first requires a court order to do so. Petition, 1/29/2024, ¶¶ 3, 5, 16-20. Petitioners alleged that FINRA "waived the requirement that Petitioners name FINRA as an additional party [to this action.]" Petition, 1/29/2024, ¶ 21. See also Petition, 1/29/2024, Exhibit 5 (FINRA Waiver Letter). For relief, Petitioners ask this court to "enter a final judgment in favor of Petitioners and enter an Order directing that FINRA expunge all references to the action styled Michael D. Moses v. Edward Jones & Co., LP, FINRA No. 23-00768 or matters therein, from the Central Registration Depository record of Jeffrey Kitchen." Petition, 1/29/2024, ¶ 30 (wherefore clause).

On February 16, 2024, the Chester County Sheriff served Michael D. Moses with the Petition, associated papers, and a Rule to Show Cause requiring a response within twenty (20) days. Certificate of Service, 1/31/2024, p. 1; Sheriff's Return, 2/23/2024, p. 1.

Presently before this court is Petitioner's Motion to Make Rule Absolute filed March 12, 2024. Petitioners aver that Michael D. Moses has not filed a response to the Petition, that the facts of the Petition are admitted, and that the Petition is unopposed. Motion, 3/12/2024, ¶¶ 5-7. Petitioners aver that C.C.R.C.P. 206.4(c)(4) gives them the right to grant of their Petition. Motion, 3/12/2024, ¶¶ 7-8.

Ordinarily, Petitioners would be entitled to relief because the Chester County Rules of Civil Procedure provide that "[i]f no answer has been timely filed, the petitioning party, not less than five (5) days after the rule return date, may move to have the rule made absolute, granting the prayer of the petition, and the Court may consider such petition as unopposed and grant such motion as of course." C.C.R.C.P. 206.4(c)(4). However, Petitioners ask this court for an order enjoining FINRA to expunge its record and FINRA is not a party to this action, nor has it been served with any legal papers. The relief Petitioners request would be a legal nullity. *E.g.*, <u>Sharpe</u> <u>v. McQuiller</u>, 206 A.3d 1179, 1184 (Pa.Super. 2019) (a judgment is void when entered by a court lacking personal jurisdiction obtained pursuant to proper service of original process, waiver, or consent). It is not enough that FINRA is aware of this action and would voluntarily obey an order from this court enjoining it to expunge its record. This court will not enter an order that is void and without legal effect.

Accordingly, for the reasons set forth above this court will enter an order denying Petitioner's Motion to Make Rule Absolute filed March 12, 2024 without prejudice.

- 2. Petitioners filed an Amended Petition for Entry of Expungement Order of Jeffrey Kitchen's Central Registry Depository record. Financial Industry Regulatory Authority (FINRA) was served and filed a Notice of Intent Not to Oppose. Defendant Moses did not file any response to the Amended Petition. The Court Held the award in the FINRA Dispute Resolution Services Arbitration was confirmed and the Occurrence Number shall be expunged from Petitioner Jeffrey Kitchen's Central Registration Depository and BrokerCheck records.

On January 29, 2024, Petitioners commenced this action by filing a Petition for Entry of Expungement Order. Petitioners alleged that Michael D. Moses brought a claim before the Financial Industry Regulatory Authority, Inc. (FINRA) against Edward D. Jones & Co., LP for mismanaging his investments, which claim was settled, but which claim remains on Jeffrey Kitchen's Central Registry Depository record. Petition, 1/29/2024, ¶¶ 1-2, 12-13, 15. Petitioners alleged that an arbitration panel recommended that FINRA expunge the claim from Jeffrey Kitchen's Central Registry Depository record but that FINRA first requires a court order to do so. Petition, 1/29/2024, ¶¶ 3, 5, 16-20. For relief, Petitioners asked this court to "enter a final judgment in favor of Petitioners and enter an Order directing that FINRA expunge all references to the action styled <u>Michael D. Moses v. Edward Jones & Co., LP</u>, FINRA No. 23-00768 or matters therein, from the Central Registration Depository record of Jeffrey Kitchen." Petition, 1/29/2024, ¶ 30 (wherefore clause).

On March 12, 2024, Petitioners filed Petitioners' Motion to Make Rule Absolute. Grant of the Motion as to Michael Moses would have been appropriate since Michael Moses was served with the Petition as original process, Michael Moses was served with a rule to show cause, and Michael Moses did not file a response to the Petition. However, Petitioners sought relief as against FINRA and this court denied Petitioners' Motion without prejudice explaining that "FINRA is not a party to this action, nor has it been served with any legal papers [and t]he relief Petitioners request would be a legal nullity." Order and Memorandum, 3/19/2024, p. 3. (citing <u>Sharpe v.</u> <u>McQuiller</u>, 206 A.3d 1179, 1184 (Pa.Super. 2019) (a judgment is void when entered by a court lacking personal jurisdiction obtained pursuant to proper service of original process, waiver, or consent)).

On March 25, 2024, Petitioners filed the Amended Petition presently before this court, which is substantially the same as the Petition filed March 12, 2024, except that Petitioners added FINRA as a party. Petitioners served the Amended Petition and a rule to show cause. Certificate of Service, 3/25/2024, p. 1. Michael Moses did not file a response to the Amended Petition. FINRA filed an Answer and Notice of Intent Not to Oppose on May 6, 2024 representing that "FINRA does not oppose the relief being sought in this proceeding with regard to Petitioners' request for confirmation of the Award, and does not intend to appear further in this action." Answer, 5/6/2024, p. 2.

Accordingly, for the reasons set forth above it is appropriate that the rule as against Michael Moses should be made absolute and the Amended Petition granted as against FINRA.
