NOTICE TO PROSPECTIVE TAX SALE BIDDERS

PROSPECTIVE BIDDERS AT ALL TAX SALES ARE REQUIRED TO PROVIDE A NOTARIZED AFFIDAVIT CERTIFYING TO THE TAX CLAIM BUREAU THE FOLLOWING:

1. Within any municipal jurisdiction, such bidder is not delinquent in paying real estate taxes owed to taxing bodies within the Commonwealth of Pennsylvania and is not delinquent in paying municipal utility bills owed to the municipalities within the Commonwealth of Pennsylvania.

2. The bidder is not the owner of any property being exposed at the upset tax sale, and is not a partner or shareholder of the owner of any property, nor in any of the following legal relationships with the owner: trust, partnership, limited partnership, corporation or any other business association.

Prospective bidders must appear at the Bureau to register for the sale and provide a notarized affidavit (per bidder) no later than Tuesday, September 12, 2023. A \$50.00 registration fee will be charged per registration form. Registration forms will not be accepted after this date. All upset sale documents, including this sale list, are available on the County's website at www.carboncounty.com, click departments, then Tax Claim Bureau.
