Parties and their counsel must check in with the Hearing Officer Clerk in Room 333, Family Law Center, and proceed to the 3rd floor waiting area until your case is called.

2. If you fail to appear at the time and place set forth above, the court may

a. dismiss the current request for court action

b. enter an order which may alter the current custodial arrangement and/or substantially affect a party's custodial rights

c. impose counsel fees

d. enter a bench warrant

e. impose fines and or other appropriate sanctions

3. The proceeding before the Custody Hearing Officer shall be governed by Pennsylvania Rule of Civil Procedure 1915.4-1, 4-2. If exceptions are filed, a brief will be required in accordance with local rules.

4. No later than ten (10) days prior to the scheduled hearing, the parties to the proceeding shall file with the Allegheny County Department of Court Records, Civil/Family a Pre-Trial Statement and serve the same on opposing counsel or opposing party, if pro-se. A copy shall also be delivered to or sent by U.S. Mail to the Custody Department, Room 333, 440 Ross Street, Pittsburgh, PA 15219. The Pre-Trial Statement shall include the following:

(a) A narrative statement of the facts which will be proven.

(b) The current custody schedule.

(c) The name of each person whom the party intends to call at trial as witnesses, including expert witnesses. The party shall also attach to the Pre-Trial Statement a report of each expert witness listed in the Pre-Trial Statement. This report shall describe the witness's qualification and experience and state the substance of the facts and opinions to which the expert is expected to testify and a summary of the grounds for each opinion. The Testimony Of Any Person Who Is Not Identified In A Timely Filed Pre-Trial Statement Shall Be Excluded At The Hearing. The testimony of an expert witness may not be inconsistent with or go beyond the fair scope of his or her report. With regard to Court appointed experts, no additional information is necessary other than the report.

(d) A list identifying all of the exhibits which the party expects to offer into evidence. Petitioner shall use numbered exhibits and Respondent shall use lettered exhibits. Only The Identified Exhibits Listed In The Pre-Trial Statement May Be Offered Into Evidence At The Hearing.

All exhibits shall be available for inspection by opposing party at any time after the filing of the Pre-Trial Statement.

(e) Each party shall submit a proposed resolution with an accompanying proposed order which he/she desires to have

implemented. If applicable or appropriate, a specific statement of the case law and/or statutory law which supports the party's position regarding the recommended order.

5. No Pre-Trial Statement or any modification thereafter may be filed beyond the deadline for filing without a written agreement of counsel or an order of court permitting the late filing. The Filing Of These Statements Is Mandatory And Appropriate Sanctions Will Be Entered If They Are Not Timely Filed. The parties shall not waive the filing of pre-trials by consent. Failure of both parties to file pre-trials will result in fines, counsel fees or other appropriate sanctions.

6. Counsel shall confer prior to the filing of Pre-Trial Statements and enter into stipulations to the fullest extent possible. Such stipulation shall be filed with the Allegheny County Department of Court Records, Civil/Family with a copy delivered to the undersigned simultaneously with the filing and delivery of Pre-Trial Statements.

7. In the event a party believes that the child or children's testimony may be necessary, the party or their counsel shall notify the Hearing Officer at least ten (10) days prior to the hearing.

8. Witnesses other than the parties may testify via the Teams electronic platform so long as all parties agree. The party calling the witness or that party's counsel shall advise the witness ahead of time to download the Teams application to their smartphone, tablet or personal computer. On the day of the hearing, the email address and telephone number of the witness shall be provided to the Hearing Officer.

9. In the absence of compelling circumstances, this case will not be continued to accommodate counsel, the parties or witnesses. Counsel, parties and witnesses must be present and prepared to proceed on the date and time scheduled.
