Drake vs. Schwartz, et al.

Summary judgment – Landlord out of possession – Duty - Overly costly or burdensome lease

- 1. Summary judgment may only be granted in those situations where there is no genuine issue as to a material fact and the moving party is entitled to judgment as a matter of law.
- 2. To establish a cause of action in negligence, a complainant must allege a breach of a legally recognized duty that is causally connected to the ultimate damages.
- 3. The existence of a duty is left to the trial court as a question of law, while the breach thereof is left to the jury.
- 4. As a general rule, a landlord out of possession is not liable for injuries incurred by third parties on the leased premises because the landlord has no duty to such persons.
- 5. Where the landlord retains control of a part of the leased premises, which is necessary to the safe use of the lease portion, he is liable to the lessee and others lawfully on the premises for physical harm caused by a dangerous condition existing upon that part over which he retains control, if by the exercise of reasonable care he could have discovered the condition and the risk involved, and made the condition safe.
- A generally economically disadvantageous lease for a tenant does not relieve the tenant of its responsibility to safely perform its duties nor does it, by itself, create liability for a landlord.
- 7. Any party may move for summary judgment as a matter of law whenever there is no genuine issue of any material fact which could be established by additional discovery.
- 8. This case involves a professional liability action brought against entities and individuals related to care decedent received at Phoenixville Nursing Home. GPH Defendants are the owners and landlords of the Property containing the nursing home and moved for summary judgment on the basis that their role was limited to that of a landlord out of possession. The question was whether the landlord had a duty to the business invitee of the tenant. Plaintiffs argued that the dangerous condition that caused the decedent's injuries was a condition of severe understaffing caused by the extreme financial limitations placed on the nursing home through GPH's lease agreement. This Court declined to create a new avenue for landlord liability based solely on a tenant's invitee alleging that the tenant's lease is overly costly or burdensome. Accordingly, the Court Held the Motion for Summary Judgment filed by Defendants' GPH Phoenixville II, LP and GPH Phoenixville II GP, LLC, was granted.

MEMORANDUM

This is a professional liability action brought against a number of corporate entities and individuals relating to the care the decedent received at Phoenixville Nursing Home, a long-term care facility operated by Defendant Phoenixville Care and Rehabilitation Center, LLC. The Fourth Amended Complaint raises the following claims against all of the Defendants: I – Nursing Home Negligence, Wrongful Death; II – Nursing Home Negligence, Survival Action; III – Corporate Negligence, Wrongful Death; and IV – Corporate Negligence – Survival Action.

At issue is the Motion for Summary Judgment filed by Defendants GPH Phoenixville II, LP and GPH Phoenixville II GP, LLC (collectively, "GPH Defendants"). GPH Phoenixville II, LP is the landlord of the property at which the Phoenixville Nursing Home is located (the "Property") and GPH Phoenixville II GP, LLC is the general partner of the landlord. For purposes of this analysis, GPH Defendants are the owners and landlords of the Property containing the nursing home.

Presently, GPH Defendants move for summary judgment on the basis of their role being limited to that of a landlord out of possession of the Property. Summary judgment may only be granted in those situations where there is no genuine issue as to a material fact and the moving party is entitled to judgment as a matter of law. Swords v. Harleysville Ins. Companies, 883 A.2d 562 (Pa. 2005).

All claims against GPH Defendants sound in negligence, thus requiring a duty on the part of GPH Defendants. <u>Martin v. Evans</u>, 711 A.2d 458 (Pa. 1998) (holding that to establish a cause of action in negligence, a complainant must allege a breach of a legally recognized duty that is causally connected to the ultimate damages).

The existence of a duty is left to the trial court as a question of law, while the breach thereof is left to the jury. Sharpe v. St. Luke's Hosp., 821 A.2d 1215, 1219 (Pa. 2003) (citing Emerich v. Philadelphia Ctr. For Human Dev., Inc., 720 A.2d 1032, 1044 (Pa. 1988); Brisbine v. Outside In Sc. Of Experimental Educ., Inc., 799 A.2d 89, 95 (Pa.Super. 2002)). The question at hand is whether the landlord had a duty to the business invitee of the tenant.

GPH Defendants argue that they are merely the landlord of the Property and the facility was operated by the "Skyline" Defendants ("Skyline" or "Tenant"). GPH Defendants are not a medical facility nor a medical service provider. GPH Defendants did not provide medical care to the decedent. In addition, they had no knowledge of the decedent's treatment and did not exercise control over the operations of the nursing home. Therefore, they argue that they are merely landlords out of possession and are not liable for the injuries incurred by the decedent. Jones v. Levin, 940 A.2d 451, 454 (Pa. Super. 2007) ("As a general rule, a landlord out of possession is not liable for injuries incurred by third parties on the leased premises because the landlord has no duty to such persons) (citations omitted). See also Kobylinski v. Hipps, 519 A.2d 488 (Pa. Super. 1986) (affirming the general rule that a landlord out of possession is

¹ Given the ultimate disposition of this motion, this court need not analyze if the general partner of the landlord could have liability through any theory of piercing the corporate veil of the landlord.

not liable for injuries to third parties and finding no duty where the tenant was in sole possession regardless of the dangerous condition of a stairwell, which was conspicuous at the time of entering the lease); <u>Kutsch v. Miller</u>, 265 A.2d 631, 635 (Pa. 1970) (holding that a landlord had no duty or liability for torts of its tenant when it exercised no control or supervision over the tenant other than insuring all mineable coal was extracted and royalties due were paid).

As additional facts, GPH Defendants note that long-term care facilities apply for and receive licensing from the Pennsylvania Department of Health (PA DOH). See e.g., 35 P.S. § 448.807; 28 Pa. Code § 201.13. The PA DOH is then tasked with inspecting the care and services of the long-term care facility at least annually, identify deficiencies, and re-inspect any corrective measures taken. 55 Pa. Code §§ 1181.83, 1181.84.

In their response, Plaintiffs note that a landlord out of possession may be liable if it retains control over the dangerous condition which caused the injury. <u>Jones v. Levin</u>, 940 A.3d 451, 454 (Pa.Super. 2007) (holding that a reserved control exception exists if a landlord has control over a defective portion of the lease premises). Plaintiffs also cite to <u>Smith v. M.P.W. Realty Co.</u>, 225 A.2d 227 (Pa. 1967) for the duty owed by a landlord when it retains control over a dangerous condition.

However, where the landlord retains control of a part of the leased premises, which is necessary to the safe use of the lease portion, he is liable to the lessee and others lawfully on the premises for physical harm caused by a dangerous condition existing upon that part over which he retains control, if by the exercise of reasonable care he could have discovered the condition and the risk involved, and made the condition safe.

<u>Id</u>. at 229 (citing: Restatement 2d, Torts, § 361 (1965); <u>Wolk v. Pittsburgh Hotels Co.</u>, 131 A. 537 (Pa. 1925); <u>Pratt v. Scott Enterprises</u>, <u>Inc.</u>, 218 A.2d 795 (Pa. 1966)).

Plaintiffs argue that the "dangerous condition" that caused the decedent's injuries "was a condition of severe understaffing caused by the extreme financial limitations placed on the nursing home through GPH's lease agreement." Plaintiff's 8/22/2022 Answer, p. 3. Plaintiffs argue that federal regulations require a nursing facility to have sufficient nursing staff and that the financial terms of the lease made it impossible for the tenant to do so. <u>Id</u>. Thus, although the reserved control exception applies most often to common areas under the control of a landlord such as shared steps, hallways, parking lots, or the like, its reach should be expanded to the present matter.

At oral argument, Plaintiffs conceded that they had no case law extending the control over a dangerous condition to a lease that is unduly economically burdensome to a tenant and that it is an issue of first impression. This court declines to create a new avenue for landlord liability based solely on a tenant's invitee alleging that the tenant's lease is overly costly or burdensome. To do otherwise would require every landlord to scrutinize the feasibility of a tenant's business, that tenant's specific business plan and competence, foresee market changes, monitor the economic health of its tenants,

potentially reduce rent agreed to in a free market, etc. That is neither feasible nor is it analogous to the retained control resulting in landlord liability found in this jurisdiction (e.g., landlord control of common areas, lighting, snow shoveling, etc.).

This holding is in line with at least two other jurisdictions addressing landlord liability with skilled nursing facilities. See Price v. TLC Health Care, Inc., 85 P.3d 838 (Ok. 2004) (finding no landlord duty when the third party allegedly received substandard medical care where landlord had no control over or participation in a resident's care); Wheeler, 113 Wash.App. 1005 (Ct. App. Wash. 2002) (not reported) (rejecting a claim that a landlord of a nursing home had liability for negligence of an operator in providing care). Here, no straight line has been alleged between any control retained or exerted by the landlord and injury suffered by a third party. A generally economically disadvantageous lease for a tenant does not relieve the tenant of its responsibility to safely perform its duties nor does it, by itself, create liability for a landlord.²

Accordingly, for the reasons set forth above, this court will enter an order granting GPH Defendants' Motion for Summary Judgment.

² Plaintiffs referenced in their answer as well as at oral argument that further discovery was being sought regarding the financial terms of the lease. Plaintiffs conceded that all discovery sought would only be to further its argument regarding the lease being economically onerous enough to establish an exception to the general prohibition on landlord liability. Given that this court finds that a landlord has no duty to study a tenant's business plan or adjust rent accordingly, regardless of a landlord's knowledge of the economic burden on a tenant caused by existing lease conditions, the Motion for Summary Judgment is ripe for disposition. "[A]ny party may move for summary judgment . . . as a matter of law . . . whenever there is no genuine issue of any material fact . . . which could be established by additional discovery." Pa.R.Civ.P. 1035.2(1).
