Proceedings held Friday, September 30, 2011

PRESIDENT JUDGE STEPHEN P. LINEBAUGH: Good morning, everyone. I want to welcome you at this time to the special meeting that has been called in honor of the memory of our departed colleague, Clyde M. Hughes, Jr.

For those who want to make comments, I would ask that you come up to the microphone where Attorney Trebilcock is so that you can -- everyone can hear you in the courtroom. Also, if you please tell us your name before you begin so the court reporter will know who is making the remarks.

So at this time I will acknowledge Craig Trebilcock who is president of the York County Bar Association.

Attorney Trebilcock.

ATTORNEY CRAIG T. TREBILCOCK:  
Thank you, Your Honor.

May it please the Court, members of the Bench, of the Bar, family, and guests. As president of the York County Bar Association, it is

my sad duty to inform the Court of the passing of one of our members, Clyde Hughes, Jr., who passed away on May 6th, 2011.

The Honorable John C. Uhler will present the minute.

SENIOR JUDGE JOHN C. UHLER: Sam Meisenhelder.

ATTORNEY CRAIG T. TREBILCOCK: I am corrected. Mr. Sam Meisenhelder will present the minute.

Other members of the Association wishing to second the minute should come forward to the podium after Mr. Meisenhelder is done and identify yourself for the stenographer so we can have an accurate record of your comments.

ATTORNEY SAMUEL MEISENHOLDER: Clyde Hughes and I were good friends. We didn't do a lot of things together, but we enjoyed each other's company. He was two years older than I, having been born on December 9th, 1920, in plenty of time for friends and relatives to select his Christmas presents each year.

He graduated from William Penn Senior High School in 1937 and Dickinson College in 1941 with a degree in psychology. He then received a Doctor of Juris Prudence degree from Dickinson School of Law in 1970. Clyde was accepted into the York County Bar in 1945. He served as the first legal aid counsel, chief legal aid counsel for Pennsylvania Workman's Compensation Fund, and as York County's first Court Administrator. He served as republican -- as a republican committeeman for the City of York and West Manchester Township. Clyde was a member of the Corpus Juris Society of Dickinson School of Law, Beta Theta Pi Fraternity, and Continental Chapter of DeMolay.

Clyde loved music. He sang in the choir at the First Presbyterian Church for 65 years. He was president of the York County -- of the York Community Concert Association and treasurer of the York Youth and Junior Youth symphonies. He had been president of the York Symphony Chorus.

He and his wife Margie loved visiting family and traveling through the numerous countries and states.

Clyde was a busy fellow, a cheerful person, and a good friend.

PRESIDENT JUDGE STEPHEN P. LINEBAUGH: Is there anyone else who would like to second the minute?

Attorney McCullough.

ATTORNEY THOMPSON J. McCULLOUGH: May it please the Court, also Margie and Susan. Clyde's wife Margie and one of their children, Susan, are here.

I'm Tom McCullough. I want to second what Sam said and also talk very briefly about Clyde as a member of First Presbyterian and then Clyde from my contact with him as an attorney.

It has already been said that he sang in the choir for 65 years. I'm astounded at that. What I know is that our church is planning to celebrate it's 250th anniversary and we asked if members had historical documents or photographs that we might use as part of the celebration. The first family that donated a historic photograph of the church were the Hughes, and I think that just symbolizes the care and the concern that Clyde and his family had for the organizations to which they belong.

Now, once I decided that I wanted to give a second I then started calling some of the other members of the Bar to share with them or have them share with me really their memories of Clyde, and the thing that jumped out at me was many of the lawyers that I've talked to all said the same thing, different words but the same thing, that the Clyde Hughes that they knew as a lawyer was an honest and conscientious lawyer.

I thought about that and I thought back to the time while Clyde was the Court Administrator, and our President Judge and I were new kids on the block then. One of the things that you did was check with the Court Administrator's Office to see where your case was on the list, mostly so that you could go back and tell your client, yes, they haven't lost it anywhere, it's coming up. Clyde had these charts, and so you would check with Clyde and he would check his chart. At least to a new kid on the block, it was comforting to know that Clyde had the chart and we could see and then report back to our clients that the case was, in fact, moving up.

He was conscientious about his duties. He was honest about his duties. That's why I think I really want to close by saying Clyde embodied York County lawyers as professionals. When he is called a conscientious and honest lawyer, I think those are terms that every one of us as lawyers hope that we, like Clyde Hughes, will be remembered as.

PRESIDENT JUDGE STEPHEN P. LINEBAUGH: Would anyone else care to second the motion that was offered by Attorney

Meisenhelder?

District Attorney Kearney.

ATTORNEY THOMAS L. KEARNEY, III: My name is Tom Kearney, and I don't think I ever encountered Clyde Hughes in the practice of law. What I do remember is being 33 years of age and running for District Attorney back in the early '80s, and at that time I believe that Clyde was a committeeman in the City of York and I stopped by his house. I believe, Mrs. Hughes, I met you at that time very briefly, but what I remember about him, and at that time I didn't, although I didn't recognize it, I probably didn't really have a prayer at getting to be DA at that time. I was naive in the way of politics and a rather young man. But I do remember being in your home and the kindness and generosity and warmth with which I was received at that time. That wasn't always the case as I was going around the county. Politicians come to learn this, but on that occasion I do recall that, and it's interesting as I hear the comments by others who knew him better that was what I saw.

PRESIDENT JUDGE STEPHEN P. LINEBAUGH: Thank you very much.

Anyone else?

Attorney Gribbin.

ATTORNEY LEO E. GRIBBIN: Your Honors, members of the family, members of the Bar.

Unfortunately, I did not have much to do in practice with Clyde. I do remember one incident which stuck out in my memory after I thought about this. When I was a young pup, Judge Atkins appointed Clyde as a master in a case that I had, and Judge Atkins called me up and asked me to come to his chambers and he gave me the order. I explained to him that I had not met Mr. Hughes. He said, You will find that Mr. Hughes is an intelligent, kind, and just man.

He was right.

PRESIDENT JUDGE STEPHEN P. LINEBAUGH: Anyone else care to second the minute? Would members of the Bench care to make a comment?

Judge Uhler.

SENIOR JUDGE JOHN C. UHLER: Upon my -- I'm Judge Uhler.

President Judge Linebaugh and members of the Bench, upon my arrival as a young pup in the York County Bar one of the first en-

counters I had with Clyde in his capacity as Court Administrator, and that was even at an early stage when I was serving my preceptorship under John Rauhauser who then was District Attorney, so the opportunity for engaging with him had a significant frequency.

Like others have said, he was extraordinarily affable, efficient, and conscientious in his role as Court Administrator. Indeed he also assisted in keeping the law library organized as well, and that was not an insignificant task at that time given the propensity of lawyers to run off with books without necessarily following the appropriate procedure.

Clyde indeed was one that had an appreciation toward an organization such as symphony, chorus, Presbyterian Church, as well as the Bar Association, and that appreciation extended to the history and the organizational structure of those entities. Like the Bar and its tradition of the minutes of respect which, of course, we are in the throws of at this moment, he felt very strongly in the perpetuation of the various organizations and the ability to memorialize their histories. I share Clyde's view as well.

Dean Wise, court reporter of long standing from the Daily Record, expressed the memory that he always encountered Clyde in the second floor in the rotunda of the old courthouse standing there and getting a sense as to what was going on and what was not going on, but he was the go-to person and one that you could rely on finding out where X and X case was being held and where you should be.

I, too, had similar experiences with that of Tom when Clyde was committeeman for the republican party, and I too engaged with the family. I truly am appreciative of Margie and Susan and their assistance in bringing this minute of respect together today.

My sincere sympathies to the family. I know he spent a number of days at the Lutheran Home where I encountered him about a year ago when I happened to be at the facility, and his memory will not be lost.

My condolences to the family.

PRESIDENT JUDGE STEPHEN P. LINEBAUGH: Thank you, Judge Uhler.

Would any other of the judges care to make any comments?

I had first met Clyde in 1972 when I was the law clerk, the only law clerk, for the judges of York County, and so Clyde and I both worked in the York County Courthouse. We had a lot of interaction because of his position as Court Administrator and mine as law clerk with regard to especially the civil matters, when they were going to be heard, and

the trials.

We had a very good relationship. Clyde was always friendly. He was always helpful. He was always a very pleasant and enjoyable individual to spend time with, and that continued, our friendship, after I began practicing law in the first few years as I was in court a good bit. As time went on, I spent less and less time in the courthouse but got to see Clyde much less frequently, mostly at Bar Association functions, but I will always remember Clyde fondly.

We direct that a copy of these comments shall be spread upon the minutes of the York County Bar Association and that a copy of the comments be sent to the family of Clyde M. Hughes, Jr.

I will now ask everyone to please rise for a moment of silence as we adjourn in memory of our colleague, Clyde M. Hughes, Jr.
