

PRESIDENT JUDGE STEPHEN P. LINE-BAUGH: Good morning, everyone. I want to welcome all of you to this Minute of Respect for our departed colleague, the Honorable Clarence "Chuck" N. Patterson, Jr.

I would ask that everyone who is going to speak, please use the microphone. And I would request that you state your name before you begin remarks for the record so that

we know who is making the various remarks.

The first thing we want to do is to recognize the Honorable John C. Uhler, former president judge of the 19th Judicial District of Pennsylvania and the current president of the York County Bar Association. Judge Uhler.

SENIOR JUDGE JOHN C. UHLER: President Judge Linebaugh, colleagues, members of the bar and friends of the late Clarence "Chuck" Patterson, Jr., it is my duty -- How

would you like me to stand?

PRESIDENT JUDGE STEPHEN P. LINE-BAUGH: I think to face the audience. We'll ask all the speakers to do that. Since the microphone is here, I think it's more appropriate for the speakers to be addressing the audience. So we'll excuse everyone's --

SENIOR JUDGE JOHN C. UHLER: Everyone's backside. By tradition, the president of the York County Bar Association presents to the Court the formal notice of the passing of

one of our late colleagues.

In that respect, it is my sad duty to report to the bench the loss of our colleague, Clarence Nicholas "Chuck" Patterson, Jr., who passed away on November 21, 2011. The Honorable Joseph C. Adams will be presenting the initial motion and Minute, and thereafter those who wish to second the Minute will be invited to do so. Judge Adams.

THE HONORABLE JOSEPH C. ADAMS: May it please the Court, President Judge Linebaugh, members and colleagues of the bench, members of the York County Bar, family and friends of Judge Patterson, it is with the greatest sorrow that I formally announce the passing of our member, the Honorable Clarence Nicholas Patterson, Jr., more affectionately known to his family, friends and colleagues as Chuck.

Judge Patterson passed away unexpectedly on Monday, November 21, 2011, in the early afternoon after having presided over a

busy morning docket.

Judge Patterson was born in Roanoke, Virginia on September 1, 1949, to the late Clarence N. Patterson, Sr., and Juanita Jackson Patterson. He graduated from the Lucy Addison High School with honors in 1967. He then went on to graduate from the Oberlin College in Ohio as part of the class of 1971. Judge Patterson graduated from law school in 1976 from the Indiana University School of Law.

At the time of his death, Judge Patterson was the widower of Cecelia Stone Patterson. Left to mourn his loss were three sons, Nick, Damon and Khamal, and he was a proud grandfather of five grandchildren.

I had the great fortune of working with Chuck on two separate occasions, first in the district attorney's office and then as a colleague on the bench. I to this day can remember my first encounter with him. It's often said that you will over time forget what people say to you, but you will never forget how they made you feel.

My first day of work in the DA's office, as was custom at the time, I was taken around to meet each of the prosecutors in their office. Each would give you a few words of wisdom, and then you would go on your way.

As you can expect, on my first day I was very nervous and apprehensive. I went into Chuck's office. I was actually taken there by Judge Kelley, and I met with him. For the life of me I cannot remember what he said to me, but I can tell you I'll never forget how he made me feel.

He was one of the most kind, gracious, warm people that I have ever met. As we all know, he had a deep, wonderful voice. His demeanor and personality quickly put me at ease. And when I left his office, I was no longer apprehensive or nervous. To the contrary, I was ready to begin the practice of law.

During my time in the DA's office, Chuck was always available to talk. He never brushed you aside or told you to come back later. He never gave you the impression that you were not important. Whatever he was doing, he put it aside and answered your question.

In responding, he wouldn't give you a cursory answer. He would give a measured response. He'd first think about it, ask you your thoughts, and then give you an answer. And he always did it with a smile.

I left the DA's office in 1998, and Judge Patterson stayed there for several more years prosecuting some of the most horrific crimes York County has ever seen. He was incredible in the courtroom. He was born to try cases, and he was at his absolute best giving a closing argument. I thoroughly enjoyed sitting in this room watching him give closing arguments to a jury.

Our paths, fortunately, crossed again in 2008 when Judge Patterson took the bench. Fortunately, he was assigned to the family division and in particular to juvenile matters, which was also my assignment.

In this assignment he really excelled. After a few years he was offered the opportunity to move to the criminal division but declined to do so because he felt he could make more of a difference working with juveniles, and he

The bench and the bar of York County lost one of its finest. Judge Patterson will always remain very much alive in the memories of those who loved him, respected and treasured him. Thank you.

PRESIDENT JUDGE STEPHEN P. LINE-BAUGH: Would anyone else like to second the Minute presented by Judge Adams? If so, please come up to the microphone and state your name. Attorney Anstine.

ATTORNEY WILLIAM B. ANSTINE: May it please the Court, my name is Bill Anstine. I think you will hear a lot of people refer to Judge Patterson as a gentleman. He was a friend of mine, and I think it might help if I define what we mean by that term, gentleman.

As Judge Adams alluded to, he was kind.

He was patient. He had excellent manners. He would always listen. He was a great listener, and he was an individual with -- He loved people. He had many talents and many abilities.

Judge Adams referred to his voice. I'm sure you all know that we have an amateur production called The Bar Stools, and one year a few years ago Judge Patterson sang a solo. I believe it was You'll Never Walk Alone. And that was not an amateur production. After that song was finished, there was resounding applause and it was a show stopper. He had a tremendous voice and he had tremendous talents.

I believe I was responsible for asking him to join the Inns of Court, and he was so well respected by his fellow attorneys that he became president of the Inn.

We traveled to London two years ago with some judges and with Judge Patterson and attorneys and met the attorneys in England. He thoroughly engaged himself in all the activities of that trip. He was a great traveling companion.

He had interesting discussions with the lawyers we met. He was very curious to see how their court system operated, and he was just a wonderful traveling companion. I know he enjoyed that trip immensely.

The judge showed his talents on the bench. He was very conscientious. He worked hard on the opinions. I know he discussed some of the things with me when we were in England that he was waiting for confirmation of a case that had gone to the Superior Court, and he received a message over there that his opinion had been affirmed. So he was very happy about that.

'If you look at the portrait here of the judge, that's how he presented himself. He was strong, dignified, just a very capable individual, but that's not exactly how I'll remember him. I will always remember his smile, which he readily gave and which always lit him up to the kind of individual that we all knew and respected. Thank you.

ATTORNEY D. MICHAEL CRALEY: Good morning, Your Honor. If it please the Court, D. Michael Craley. I'd also like to second the Minute

I first got to know Judge Patterson back in the mid-1980s. He started out with Attorney Harris. I was with Attorney McNeal. We were part of the crew that used to walk up Court Street to the back of the courthouse. Judge Blackwell, Michelle Kahan, a number of us were able to do that in the days before security made that impossible.

Our paths then went in a different direction. Chuck went to the district attorney's office. I went into private practice as a sole practitioner in Red Lion. We didn't see each other very often, but every time we did, I, too, remember that smile. That's what we all remembered him by.

Our paths came together again in 2009

when he ran for judge. My wife Theresa was his campaign manager. And for all of you who have ever been through that, you know that there's a lot of time spent together. It was always about juveniles. He had spent a long time in the district attorney's office prosecuting criminals. He didn't want to do that. He wanted to get the kids and help them before they got into trouble.

And I'll never remember -- A day that probably said a lot was the May day of 2009 in downtown York. We were there. We had a space and we looked around for Chuck. And where was he? He was giving balloons out to

the young children.

And that was a day that at the end was marred by a tragic shooting on South Duke Street, and I remember the anger. You didn't see it very often with Chuck, but that day it was the anger and the senselessness of what happened, at the fact that he knew that by going on the bench he wouldn't be able to prosecute that offender.

But when he got to the bench, my wife and I were still able to have dinner with him as our schedules permitted, which, unfortunately, was only about once or twice a month. He would always talk to us about the juveniles, about who he was able to make a difference for.

It meant a lot to him that later on people who he had seen in adjudications and delinquencies came up to him and said, Judge Patterson, you changed my life, you sent me in the right direction.

As Judge Adams indicated, he didn't want to go to a different assignment. He simply wanted to stay with the juveniles. He always talked to us about that, that and his "grands", as he referred to his grandchildren. And I'll miss him a lot. I second the motion. Thank you.

ATTORNEY CHRISTOPHER A. FERRO:

May it please the Court.

PRESIDENT JUDGE STEPHEN P. LINE-

BAUGH: Attorney Ferro.

ATTORNEY CHRISTOPHER A. FERRO: My name is Chris Ferro. Members of the bench, family and friends of Judge Patterson and fellow members of the bar, I rise to second the Minute in favor of our dear friend and lost colleague, Judge Patterson.

Teddy Roosevelt once said that courtesy is as much the mark of a gentleman as is courage, and anyone who has ever tried a case with or against Judge Patterson will tell you and know that he was a courageous fighter, a dogged advocate within these courtroom walls for children, for victims, and ultimately for justice, but, more importantly, outside of these courtroom walls.

And again, quite frankly, for anyone who has ever tried a case with or against him within this arena, he was a true gentleman, a courteous man to a fault, kind and warm.

My memory of Judge Patterson will not just be the bellowing closing arguments, the

aggressive cross examination. It will be more the handshake, the kind words, the warm smile. He was in all respects of the word a true gentleman, and he will be missed by all of us. May he rest in peace.

ATTORNEY THOMAS L. KEARNEY, III: Please the Court, my name is Tom Kearney. I'm the district attorney of York County, but I spent most of my days with Chuck trying cases for the defense. We did a lot of homicides together.

I remember thinking in one of his closing arguments that whatever the voice of God sounded like, somehow Chuck inherited it. He just was magnificent. Sometimes I'd sit there and say, wow, that was impressive, and I'd think what did he say? It sure sounded good.

I was privileged to be along on the trip through the Inns of Court to England that Bill Anstine just spoke about. My fondest memory will always be the day that Chuck and I spent together at the British museum. We were like two kids in a candy store. We had a wonderful lunch at a British pub. It was just a wonderful day.

I was privileged to be with Chuck when he passed away. We give titles to those who sit on the bench of Your Honor. Those were the last words that he heard from me because we were greeting one another in our customary fashion, and I'm very proud to say that those are the last words that I think he heard. And I think from all of us here, we wish we would have had that opportunity that I was blessed with to say those words to him because I know we all would have meant it. Thank you.

PRESIDENT JUDGE STEPHEN P. LINE-BAUGH: Would anyone else care to second the motion? Are there any members of the bench who would care to make any comments? Judge Marceca Strong.

THE HONORABLE ANDREA MARCECA STRONG: May it please the Court, members of the bench, the bar, friends and family of the Honorable Chuck Patterson, I, too, second the motion for the Minute today. Chuck was a true gentleman, a kind man, and everyone who knew him respected and liked him.

Judge Penny L. Blackwell could not be here today, and the following are her comments: "I, unfortunately, could not attend today's memorial Minute for Judge Patterson but wish to convey to his family as well as to the bench, bar and friends how much he will be missed.

One of the first dealings I had with Chuck involved me calling him up to my chambers from the DA's office to talk to a young man in my courtroom. This young man was in a courtroom full of people he did not know nor could he relate to as he was awaiting a decision about his future.

Chuck was kind enough to appear in court, take the time to speak with the young man, and then relate what the feelings of this young man were. As the two discussed mat-

ters, I could see the young man relax and actually smile at the end of the conversation.

Chuck enabled this young man to trust that the process he was undergoing was for his benefit and not to harm him. This act of kindness was part of Judge Patterson's soul, and he carried it onto the bench. I will miss not just his friendship but his presence as a judge who passionately cared for assuring justice was served in a humane manner. Thank you."

THÉ HONORABLE HARRY M. NESS: Thank you. Colleagues, members of the bar, family members and friends of Chuck, I, too, share in all the observations that we've heard here this morning regarding Chuck.

I had known him for about 30 years. And while we were almost always on opposite sides of the issue, he being a prosecutor, myself being a defense attorney, I never once felt that we were on opposite sides of justice.

He maintained his integrity throughout, he maintained his sense of fairness throughout, and he treated both myself, my client, the public and the Court with the dignity that they deserved in spite of the circumstances.

He was, as was observed, a great orator. I enjoyed the trials I had with him, and I don't ever feel like I had a trial against him.

I enjoyed the time that we spent campaigning together. We made a decision when we started the campaign to run for judge that we would run together. We walked neighborhoods together. We shook hands together. We shared meals, conversations and friendship, and that I'll miss.

One of the things I always admired about Chuck is he shared with me an observation that clothing were not just to cover the nudity of the human form. He dressed beautifully. He was sartorial.

He spoke well, and I was honored to be elected with him, I was honored to share the bench with him, and I'm sad that he's gone.

THE HONORABLE JOHN S. KENNEDY: I'll second the Minute as well. I met Chuck for the first time in 1987 when I was in the DA's office and he was working with James Harris on Princess Street.

Actually, at that time they lived to the right of my house and Mr. Craley and Mr. McNeal were to the left of my house, so we were all kind of Princess Street people.

But I remember seeing briefs that Chuck would write and they were so well written. And eventually I went to Stan Rebert and said, Stan, you ought to look at these briefs, and if you've got an opening, you might want to think about hiring this guy. And shortly thereafter he was hired.

And Chuck and I remained in contact then for quite some time. And actually, before I ran for judge in 1995, I went and met with Chuck and said, Chuck, I'm thinking about running for judge, but if you are going to run, let me know and I won't run. And Chuck said it's not my time yet, he said, I've got some issues I'm

dealing with and I don't think I should run.

Later on Chuck had served as a mentor for my son. And I don't know how many of you were able to attend his funeral. I see a lot of folks here that were there, and we all know how crowded that was. It was real clear at the funeral the impression he made on the York community.

There were speeches of how he frequented various of the African-American churches within the York community on a regular basis and how close members of the York community felt to him. He's clearly a loss to the community. His loss is a big loss to the community.

When he did get elected, I had the great fortune of having him pick a chambers on my floor and he was just down the hall from me. And my secretary loved hearing him come and go. He was always cheerful. There were times when he was singing or humming. And that's I think how most of us remember him. And for most of us, he wasn't really Judge Patterson for most of us. He was Chuck.

Chuck had a real love for his grandchildren. I can't tell you how often he'd stop in my office and talk about how he was going to get to go to Roanoke and hang out with his son and, more importantly, his grandchildren. He clearly loved his family, and he was just a wonderful man.

He truly felt that the job that he did was important, but he never made you feel like he was important. He was just a great man, and he's a great loss to our bench and a great loss to the York legal community and the community at large. His family should be proud of him, and we sympathize with your loss.

THE HONORABLE THOMAS H. KELLEY, VI: I'd also like to second the Minute. Members of the bench, bar, friends, et cetera, Chuck was my first supervisor in the DA's office, and I like to think that he taught me well. And I know indeed he did teach me well.

Everyone has commented on his legal acumen. I'd like to kind of comment on something a little bit different, and that is the fact that, well, Chuck was a trailblazer. What his real blazing was is a beautiful human being who was able to be a success in a business where there's nothing but contentiousness.

When Oliver Wendell Holmes met President Roosevelt for the first time, he remarked as he was leaving, he said "a first class temperament." And that was probably the highest praise that someone as intellectual as Holmes could give, and that's what I'd like to say about Chuck: a first class temperament, a beautiful individual who made everyone about him feel better about themselves, who made you want to be better and a better person.

That's what he brought into the contentiousness that we deal with every day. That's why everyone who comments on it says they don't feel like they were trying cases against Chuck, they were trying cases with Chuck in the pursuit of justice. And you could walk out

of a courtroom after fighting against Chuck and feel better for having seen such a great person and a great human being in action.

I have a lot of personal anecdotes that I could tell about Chuck, but those are personal to me. I can tell you at this point in time that I sincerely loved him and we are all worse for having lost him. Thank you.

THE HONORABLE JOHN W. THOMP-SON, JR.: Judge Thompson. I certainly endorse every comment that has been made and all the sentiments that have been ex-

pressed about Judge Patterson.

As has been alluded to, his interest in juveniles was paramount. Chuck believed and understood that if we did not help our youth through their troubling circumstances, our society was in trouble.

Chuck accepted an extra assignment of the Juvenile Drug Treatment Court. Judge Patterson accepted the time away to go to training, and he and I attended a training in

Washington, D.C.

What was ultimately impressive about Judge Patterson was after the sessions, he would not just accept what the trainers were telling the judges to do. We had many hours of conversation about why we did things and how we could do them better, and I credit Chuck's intellectual curiosity and his insight into youths that improved how we did juvenile drug treatment.

I personally will miss him greatly, and I

give my condolences to the family.

SENIOR JUDGE JOHN C. UHLER: Some brief snippets. Bill Anstine as part of his second referenced Chuck's involvement with the Herbert B. Cohen Inn of Court and he ascended to the presidency, and the mission of that organization is to advance professionalism, civility, as well as fine tune the skills that lawyers should display in a courtroom setting.

He recently was recognized posthumously with the Richard I. Kohler award, Honorable Richard I. Kohler award for civility and professionalism by the Inn of Court at our June meeting. His participation in that organization helped advance it and to augment the numbers of individuals, members of the bar, that had been invested in that particular program.

As one of the cast members of the Inns of Court, it was very apparent that we should all be ashamed of ourselves but for Chuck. He was clearly the class act and we essentially were class clowns in comparison when involved with the Bar Stool productions.

In all of my encounters with Chuck, his family was indeed paramount, always alerting as to prospective trips, the pride he had in the achievements that the family members had.

And as a final note, I've encountered constituents from York County too numerous to mention, all of whom have lamented the premature loss and passage of Chuck. We will miss him greatly. My sympathies to the family.

PRESĬDENŤ JÚDĠE STEPHEN P. LINÉ-BAUGH: Any other judges care to make a comment?

The Honorable Maria Musti Cook could not be present today, and she asked me if I would read some remarks from her. "I regretfully could not be present today as a result of a prearranged trip out of the country. However, I want to second the motion so ably presented.

The first thing I ever learned about Chuck was that he had the most beautiful voice, one of the very few actually talented Bar Stools members, but I learned of Chuck's voice before Bar Stools at the annual DA sing-along, and I tried to make it a practice to be there to hear Chuck and the late Judge Cassimatis.

One of my personal favorite memories was the pleasure of having Chuck sing happy birthday to me at one of our monthly judicial conferences that fell on my birthday in 2011. When Chuck sang, it was a voice from heaven and it was always mesmerizing to the crowd. Chuck had the same effect in the courtroom.

And when we campaigned during the 2005 primary, in 2005 it was a pretty tight group of candidates during the primary, and I remember the night Judge Adams, Chuck and I raced to Dillsburg to shake hands and introduce ourselves and then raced back to York for opening night of a Bar Stools production. It was a great ride back to York. The three of us thought we must be crazy to be performing the week before the primary.

When Chuck came on the bench, he took his duties very seriously and he had a real desire to reach out to the juveniles that appeared before him. I never saw Chuck get angry or lose his temper. He was always a gentleman, firm but fair in the courtroom. He wanted to make a difference, and he did.

His responses to general e-mails sent about issues that would arise were always thoughtful and respectful of his colleagues.

We had great elevator conversations at the end of a number of long days. We would comment on each other's day, and then usually the conversation would roll around to wardrobes right down to where we shop for shoes. He was the epitome of fashion. Even when we were at conferences, Chuck's casual attire was impeccable.

Chuck was a very private person, but he shared some insight into his commitment to his family by bringing his son Khamal to the State Trial Judges Conference in 2011. I was impressed with how interested Khamal was in every session he attended, and it was wonderful to observe the interaction and pride between father and son. We miss him here, and my sympathies to his family." Maria Musti Cook.

Any other judges? I certainly agree with everything that was said about Chuck Patterson, who was such a tremendously wonderful human being, such a gentleman. His robe will be a difficult one to fill.

We direct that a copy of these comments be spread upon the minutes of the York County Bar Association and that a copy be sent to the family of the Honorable Clarence "Chuck" N. Patterson, Jr.

Please rise for a moment of silence as we adjourn in memory of the Honorable Clarence N. Patterson. We are now adjourned in the memory of Judge Patterson.
