

Obiter Dictum

From the ABA Journal Daily Newsletter: [1] A federal judge in Texas appeared exasperated with government lawyers when he ruled that the U.S. Department of Commerce's Minority Business Development Agency unconstitutionally denies benefits based on race and barred the agency from applying a statutory presumption that certain minorities are socially or economically disadvantaged which entitles them to benefits under the program. According to the Court, the presumption violates the due process clause. The government had argued that the presumption is constitutional because it remedied past discrimination in which the government "passively participated." One allegedly discriminatory issue involved credit access. Questions that must be answered are whether incidents of historic discrimination caused minority businesses to have less access to credit and if the problem is rooted in private sector disparities, whether the government participated in causing it. The evidence shows that minority businesses are more likely to be denied loans, get less money when they apply and must pay more for it, the government had argued, but the Court determined that the government must identify past incidents of discrimination that caused the problem. According to the Court, "while the government identifies a few concrete examples of past discrimination, the record fails to trace those few examples to modern disparities today. If the record contains more specifics the agency fails to identify them and while the Court expended hundreds of man hours reviewing the record, it isn't the Court's job to mine a 4,456page record to find better evidence for the agency." The Judge also chided the government for offering scant evidence that the government participated in credit discrimination. [2] A suspended criminal court judge has been booked into a Memphis, Tennessee jail after she tested positive for cocaine while awaiting a trial on charges of coercing a witness and harassment. Judge Roy Morgan of Tennessee revoked bond for Judge A. Melissa Boyd of Shelby County, Tennessee. Besides facing criminal charges, Boyd has received two public reprimands since she became a judge in September 2022. She was criminally charged in December with harassment and trying to coerce or influence her former campaign manager to testify falsely or withhold truthful testimony in an official proceeding. The trial is scheduled for April 24.
