NOTICE IS HEREBY GIVEN that the Board of Supervisors of the Township of Asylum shall hold a public meeting on May 3, 2022 at 7:00 P.M., for the purpose of conducting a public hearing and to consider adoption of an ordinance to regulate and designate all township roads to be shared by all-terrain vehicles, snowmobiles and vehicular traffic and for any other such action as may come before the Board of Supervisors. Said meeting shall be held at the Asylum Township Building, 19981 Rt. 187, Towanda, PA. All persons with disabilities wishing to attend the public meeting and needing reasonable accommodations should contact the Township Secretary at (570) 265-4339 no later than 72 hours prior to the scheduled meeting. Asylum Township will make every reasonable effort to provide accommodation. The full text of the ordinance is set forth below.

AN ORDINANCE OF THE TOWNSHIP OF ASYLUM, COUNTY OF BRADFORD, COMMONWEALTH OF

BRADFORD COUNTY LAW JOURNAL

PENNSYLVANIA TO REGULATE THE DESIGNATION OF ALL TOWNSHIP ROADS AS ROADS TO BE SHARED BY ALL-TERRAIN VEHICLES, SNOWMOBILES AND VEHICULAR TRAFFIC IN THE TOWNSHIP OF ASYLUM; CONTAINING A SAVINGS CLAUSE; FURTHER CONTAINING REPEALER PROVISIONS; AND SETTING THE EFFECTIVE DATE FOR SAID ORDINANCE.

WHEREAS, the Board of Supervisors of Asylum Township has determined that un-regulated roads for shared used by all-terrain vehicles, snowmobiles and vehicular traffic poses a risk to the health, safety and welfare of the citizens of Asylum Township and the general public; and

WHEREAS, the Board of Supervisors finds that a joint use road designation ordinance to be in the best interest of the health, safety and welfare of the citizens of Asylum Township; and

NOW, THEREFORE, be it ENACTED and ORDAINED by the Board of Supervisors of Asylum Township, Bradford County, Pennsylvania and it is hereby ENACTED and ORDAINED by the authority of the same as follows:

Section 1—Purpose

The purpose of this Ordinance is to designate all Township Roads in Asylum Township as All-Terrain Vehicle and Snowmobile roads, to permit the designated roads to share All-Terrain Vehicles, Snowmobiles and vehicular traffic.

Section 2—Definitions

The term “All-Terrain Vehicle” or “snowmobile” shall be as defined in the Pennsylvania Motor Vehicle Code, as amended. (75 Pa. C.S. §101 et seq.)

Section 3—Designation

Except as provided hereinafter, all roads within the Township of Asylum are hereby designated as “Joint Use All Terrain and Snowmobile” so as to permit said roads to

be shared by All Terrain Vehicles, snowmobiles, and vehicular traffic. All state roads and private roads are excluded from this designation.

Section 4—Liability

(1) In accordance with the Pennsylvania Motor Vehicle Code, Asylum Township assumes no liability whatsoever as a result of designating any of the aforesaid Township Roads to be shared by all terrain vehicles, snowmobiles and vehicular traffic.

(2) All provisions of the Pennsylvania Motor Vehicle Code remain in full force and effect on all Township Roads.

Section 5—Severability

If any section, clause or provision contained in this ordinance is deemed to be illegal, unconstitutional, or otherwise invalid, such illegality, unconstitutionality or invalidity shall not affect the remaining provisions of this ordinance and it is hereby declared to be the intent of the Board of Supervisors that such ordinance would be adopted even had such illegal, unconstitutional or invalid provision have not been included herein.

Section 6—Repealer

All ordinances or parts thereof which are inconsistent with the provisions of this ordinance are hereby repealed.

Section 7—Effective Date

This Ordinance shall become effective immediately upon enactment.
