OPINION BY ASHWORTH, P.J., January 26, 2022. Before the Court is Alejandro Cruz-Santiago's pro se petition filed pursuant to the Post Conviction Relief Act (PCRA), 42 Pa. C.S.A. §9541-46. For the reasons set forth below, this petition will be dismissed without a hearing.<sup>1</sup>

### I. PROCEDURAL BACKGROUND

On June 22, 2017, Petitioner was charged at Information No. 2365-2017 with criminal homicide, burglary of an occupied structure, criminal conspiracy (homicide), and criminal conspiracy (burglary),<sup>2</sup> stemming from criminal activity occurring in Providence Township, Lancaster County, Pennsylvania. On the night of March 22, 2017, Petitioner and a co-defendant<sup>3</sup> unlawfully entered the residence of victim Hugo Ernesto Garcia-Hernandez with the intent to rob the victim. During the course of this crime, the victim was shot and killed by his assailants. Randall L. Miller, Esquire, was initially court-appointed to represent the indigent Petitioner on all charges, however, the Court later rescinded that appointment due to a conflict of interest and on May 2, 2017, appointed Christopher P. Lyden, Esquire to serve as Petitioner's trial and appellate counsel ("trial counsel").

On June 6, 2019, Petitioner appeared before the undersigned and tendered a negotiated guilty plea. Petitioner pled guilty in accordance with the Plea Agreement to criminal homicide (amended to third degree), burglary, and criminal conspiracy (burglary). The Commonwealth entered a nolle pros on the criminal conspiracy (homicide) charge. After reviewing the seven-page, seventy-eight paragraph Guilty Plea Colloguy and Post-Sentence Rights form completed by Petitioner with his trial counsel, and after conducting an extensive oral colloquy on the record, the Court accepted the Plea Agreement and Petitioner's guilty plea, finding he entered his plea knowingly, intelligently, and voluntarily. Petitioner waived his right for a presentence investigation and stood for sentencing that same day. The Court sentenced Petitioner to the agreed upon aggregate term of incarceration of twelve to twenty-five years in a state correctional institution, plus restitution and costs.<sup>4</sup> Notes of Testi-

Under Pa. R.Crim.P. 907, a PCRA court may dispose of post-conviction collateral relief petitions without a hearing if it is satisfied after reviewing the materials submitted that no genuine issues of material fact exists and that petitioner is not entitled to relief. See also Commonwealth v. Springer, 961 A.2d 1262,

 Specifically, Petitioner was sentenced to 12-25 years' incarceration on the third degree criminal homicide,

mony ("N.T.")<sup>5</sup> at 12-13. Petitioner was not eligible for a Recidivism Risk Reduction Incentive ("RRRI") sentence due to the homicide conviction. No post sentence motion was filed, and no direct appeal to the Superior Court of Pennsylvania was taken.

Acting *pro se*, Petitioner filed a timely<sup>6</sup> petition for post-conviction collateral relief on June 10, 2020,<sup>7</sup> challenging his guilty plea. Pursuant to Rule 904(A) of the Pennsylvania Rules of Criminal Procedure, Daniel C. Bardo, Esquire ("PCRA counsel"), was appointed to represent Petitioner on his collateral claims and was granted leave to file an amended petition. On October 12, 2020, PCRA counsel filed a petition for leave to hire a forensic psychiatrist and to stay the PCRA proceedings until such time as an expert could be retained, evaluate Petitioner, and render an opinion and report on Petitioner's mental health and competency. After conferring with PCRA counsel, the Court entered an Order on October 22, 2020, granting the petition to stay the PCRA proceedings, but deferring decision on retention of a forensic psychiatrist pending the production of documentation of a mental health condition that could have rendered Petitioner incompetent at the time of his guilty plea. The Court set a deadline of thirty days after the date of said Order but informally extended this timeframe several times to accommodate PCRA counsel's diligent investigative efforts to locate records Petitioner insisted existed.

Ultimately, PCRA counsel was unable to obtain any psychiatric medical records for Petitioner, and after a careful and conscientious review of the entire record, concluded the petition did not present any issues of arguable merit and was frivolous as a matter of law. Accordingly, on June 5, 2021, PCRA counsel submitted a "no merit" letter<sup>8</sup> to Petitioner and filed a motion to withdraw with the Court. After reviewing the pro se PCRA petition, counsel's "no merit" letter, and conducting an independent review of the record, the Court found there were no disputed issues of fact, Petitioner was not entitled to post conviction collateral relief, and no purpose would be served by any further proceedings. Therefore, pursuant to Pa. R.Crim.P. 907 (1), the Court filed a notice of intent to dismiss the PCRA petition without a hearing, allowing Petitioner additional time within which to file a pro se amended petition or to otherwise respond to the Court's Notice. No response by Petitioner has been filed, and this matter is ripe for adjudication.

signed on June 6, 2019. 6 Pursuant to 42 Pa.C.S.A. § 9545(b), a petition for relief must be filed within one year of the date the judg-ment of sentence becomes final. For purposes of the PCRA, a judgment of sentence becomes final at the conclusion of direct review, including discretionary review in the Supreme Court of Pennsylvania, or at the expiration of the time for seeking such review. *Id.* at § 9545(b)(3). See also Commonwealth v. Jones, 54 A.3d 14, 17 (Pa. Super. 2012). As Petitioner did seek direct review with the Pennsylvania Superior Court, his judgment of sentence became final on July 6, 2019, when the period for filing an appeal with the Superior Court expired (30 days after the guilty plea and sentencing hearing of June 6, 2019). Petitioner's pro se PCRA petition was placed into the prison mail system on June 10, 2020 and was docketed on June 15, 2020; it is timely. See Filing Discussion, *infra* n6. 7 Pursuant to the "prisoner mailbox rule" the pleading is deemed filed on the date of mailing rather than the date of docketing. See Commonwealth v. Unfortunately, the envelope in which the instant petition was sent to the Court is no longer available, rendering it is impossible to discern the precise date of posting. Fortunately, Cruz filed this petition well within one year from the date his judgment of sentence became final on February 27, 2020, so the exact date of posting is irrelevant to this particular matter. 8 This was filed pursuant to *Commonwealth v. wealth v. Finley, 379 Pa. Super. 390, 550 A.2d 213 (1988), and their progeny.

## **II. DISCUSSION**

Generally, "a plea of guilty amounts to a waiver of all defects and defenses except those concerning the jurisdiction of the court, the legality of the sentence, and the validity of the guilty plea." *Commonwealth v. Morrison*, 173 A.3d 286, 290 (Pa. Super. 2017) (citation omitted). Here, there are no grounds for challenging the jurisdiction and authority of this Court to prosecute Petitioner. Neither does the record support an allegation that the individual sentences imposed on Petitioner were not legislatively permitted.<sup>9</sup> Rather, the only possible basis for post-conviction collateral relief under the PCRA would be that Petitioner's guilty plea was not knowingly, voluntarily, and intelligently made; no evidence to support such a claim exists here.

In assessing the validity of a guilty plea, our Superior Court has noted that "[t]he law does not require that [the defendant] be pleased with the outcome of his decision to enter a plea of guilty; rather [a]ll that is required is that [the defendant's] decision to plead guilty be knowingly, voluntarily and intelligently made." *Commonwealth v. Brown*, 48 A.3d 1275, 1277 (Pa. Super. 2012) (citations and internal quotation marks omitted).

> With regard to the voluntariness of a plea, a guilty plea colloquy must affirmatively demonstrate the defendant understood what the plea connoted and its consequences. Once the defendant has entered a guilty plea, it is presumed that he was aware of what he was doing, and the burden of proving involuntariness is upon him.

*Commonwealth v. Willis*, 68 A.3d 997, 1002 (Pa. Super. 2013) (citations and internal quotations omitted). In determining whether a defendant entered into a plea of guilty knowingly, voluntarily, and intelligently, a court "is free to consider the totality of the circumstances surrounding the plea, . . . including, but not limited to, transcripts from other proceedings, 'off-the-record' communications with counsel, and written plea agreements." *Commonwealth v. Allen*, 557 Pa. 135, 146-47, 732 A.2d 582, 588-89 (1999). Moreover, "[a] defendant is bound by the statements made during the plea colloquy, and a defendant may not later offer reasons for withdrawing the plea that contradict statements made when he pled." *Brown*, 48 A.3d at 1277. Where the defendant enters his plea on the advice of counsel, "[t]he voluntariness of [the] plea depends on whether counsel's advice was within the range of competence demanded of attorneys in criminal cases." *Commonwealth v.* 

The individual sentences imposed by this Court on Petitioner are clearly legal sentences as each falls well below the permissible statutory maximum. An individual convicted of the crimes to which Petitioner pled guilty faces a statutory maximum of: 40 years incarceration and a fine of \$50,000 (homicide in the third degree); 20 years incarceration and a fine of \$25,000 (burglary); and twenty years incarceration with a fine of \$25,000 (conspiracy/burglary), for a possible aggregate sentence of 80 years incarceration and \$100,000 in fines. Thus, Petitioner's agreed upon sentences of 12-25 years' incarceration (homicide in the third degree), 10-20 years' incarceration (conspiracy/burglary) (concurrent), and zero fines are clearly legal sentences. Again, Petitioner was sentenced to an aggregate of just 12-25 years' imprisonment, well below the statutory maximums for the serious crimes he admitted to committing.

Lynch, 820 A.2d 728, 732 (Pa. Super. 2003) (citation omitted).

To analyze the voluntary, knowing, and intelligent nature of Petitioner's plea, the Court examines the totality of the circumstances surrounding it. The procedure for pleas and plea agreements is set forth in Rule 590 of the Pennsylvania Rules of Criminal Procedure. Before a trial court may accept a plea of guilty, it must determine, after inquiry of the defendant, that the plea is voluntarily and understandingly tendered. Pa.R.Crim.P. 590(A)(3).<sup>10</sup> The comment to this Rule notes that "at a minimum," the judge should ask the following questions in the guilty plea colloquy: (1) Does the defendant understand the nature of the charges to which he is pleading guilty; (2) Is there a factual basis for the plea; (3) Does the defendant understand that he has the right to trial by jury; (4) Does the defendant understand that he is presumed innocent until he is found guilty; (5) Is the defendant aware of the permissible range of sentences and/or fines for the offenses charged; and (6) Is the defendant aware that the judge is not bound by the terms of any plea agreement tendered unless the judge accepts such agreement. Commonwealth v. Hart, 174 A.3d 660, 667 (Pa. Super. 2017). Our Supreme Court has held that inquiry into these six areas is essential to ensure a knowing, voluntary, and intelligent plea. Commonwealth v. Flanagan, 578 Pa. 587, 605, 854 A.2d 489, 500 (2004).

The comment to Rule 590 does allow that a determination into these areas may be accomplished by a written colloquy that is "read, completed, signed by the defendant, and made part of the record of the plea proceedings," supplemented by some on-the-record oral examination. In this case, the undersigned did specifically inquire on the record into the six designated areas identified above (N.T. at 3-9), and Petitioner also completed a seven-page written colloquy through which he manifested his understanding of the offenses against him, the maximum sentences, and the procedural due process rights waived by a guilty plea. (Id. at 8-9); see also Guilty Plea Colloquy. Petitioner indicated that he reviewed the colloquy form with his attorney and signed it. (N.T. at 8-9). Furthermore, while Petitioner answered "yes" on the written colloquy that he had been treated for mental illness in his past, he further indicated that such "illness or its treatment" did not affect his "ability to understand these questions or why [he is] here today [at the Guilty Plea Hearing]." Guilty Plea Colloguy at  $\P\P$  5, 6. Thus, the record clearly establishes that Petitioner was aware of his charges (N.T. at 4-6), that he understood the nature of these charges (Id.), and that he was giving up his right to a jury trial and the presumption of innocence (*Id.* at 3-4). Moreover, Petitioner indicated that he knew he did not have to plead guilty and that it was his voluntary decision to plead guilty. (Id.); see also Guilty Plea Colloquy at ¶¶ 10, 49. Petitioner denied being forced to plead guilty and indicated that it was his decision to plead guilty of his own free will. Guilty Plea Colloquy at ¶¶ 50-51; see also N.T. at 11.

As required by Pa.R.Crim.P. 590, this Court must also satisfy itself that there was a factual basis for the plea. Commonwealth v. Fluharty, 429 Pa. Super. 213, 219, 632 A.2d 312, 315 (1993). In the instant case, there was substantial independent evidence of guilt on all three charges, as acknowledged by Petitioner and his counsel. (N.T. at 9-10). Furthermore, in exchange for the plea agreement, Petitioner testified against co-defendant Ferrufino at his trial, over which the undersigned presided and received all evidence and testimony. In light of the totality of the circumstances surrounding the plea in this case, it is clear there was a sufficient factual basis to support Petitioner's guilty plea. By the nature, extent, and tone of the guilty plea hearing, and especially the discussions held by the Court directly with Petitioner on the record, this Court was well satisfied that Petitioner was fully competent to enter his guilty plea. Further, the Court was and still is confident that Petitioner's trial counsel fully executed his duties in advising Petitioner of the nature of the charges and the possible consequences of a guilty plea, and that Petitioner was competent to understand those consequences, contrary to his present claims. Thus, considering all the circumstances attendant to the plea, including the adequacy of the written and oral plea colloquies, Petitioner's responses therein, and the representations by Petitioner's trial counsel, the guilty plea was entered knowingly, voluntarily, and intelligently.

As far as Petitioner's relatively recent assertion that he was incompetent at the time of the plea to understand its meaning and consequences due to the effects of some undisclosed mental illness, the Court finds this claim to be without merit. This Court stayed the PCRA proceedings and granted PCRA counsel ample opportunity to uncover and produce medical documentation of any mental illness that might have rendered the Petitioner incompetent at the time of his plea. PCRA counsel engaged in a diligent yet unsuccessful effort over a period of months to locate the medical records Petitioner claims exist. As recounted in PCRA counsel's no merit letter to Petitioner, counsel obtained Petitioner's signed records release form and enlisted the help of Petitioner's sister in locating and securing any relevant mental health documents but no records have been returned. As such, the Court has no choice but to accept Petitioner's original answers to the Plea Colloquy and find that although Petitioner may have at some time been treated for an unnamed mental illness, at the time of the plea he was fully competent to understand the nature and consequences of entering into the plea agreement and pleading guilty in this matter. See Brown, 48 A.3d at 1277. Although the Petitioner may now regret having accepted the agreement offered by the Commonwealth, such regret is of no actionable consequence to this Court. Id.

## **III. Conclusion**

For the reasons set forth above, Alejandro Cruz-Santiago's *pro se* PCRA petition fails to state any issues of merit and must be denied and dismissed without further proceedings.

Accordingly, I enter the following:

# ORDER

AND NOW, this 26th day of January, 2022, upon consideration of Alejandro Cruz-Santiago's *pro se* petition for post-conviction collateral relief, it is hereby ORDERED that said petition is DENIED without a hearing. There are no genuine issues concerning any material fact, Cruz-Santiago is not entitled to post conviction collateral relief, and no purpose would be served by any further proceedings.

Further, the no-merit letter of Defendant's court-appointed attorney, Daniel C. Bardo, Esquire, states that the *pro se* petition is lacking in merit as a matter of law, a conclusion with which the Court agrees after its independent review of the record. Accordingly, Mr. Bardo is GRANT-ED his request for leave to withdraw as counsel.

Pursuant to Pa. R.Crim.P. 907(4), this Court advises Cruz-Santiago that he has the right to appeal from this Order. Cruz-Santiago shall have **30 days** from the date of this final Order to appeal to the Superior Court of Pennsylvania. **Failure to appeal within 30 days will result in the loss of appellate rights.** 

It is further ORDERED that Cruz-Santiago shall have the right, if indigent, to appeal *in forma pauperis* and to proceed with assigned counsel as provided in Pa. R.Crim.P. 122.
