

The York County Bar Association and Foundation believe that, although it is important to promote more minorities to senior level positions within the legal profession, those efforts will be hampered if there are still too few minorities who decide to enter the profession in the first place. Beginning in 2005, the Bar Association convened its diversity committee to look at ways in which diversity in the legal profession could be enhanced. Programs were initiated to encourage minority students to consider law–related employment within the York community. In 2007, the diversity committee encouraged the Bar Foundation to establish the then Diversity Pipeline Internship program and began efforts to raise funds for this purpose.

The Clarence "Chuck" N. Patterson (CNP) Diversity Internship Scholarship program, renamed after the untimely passing of Judge Patterson in 2011, provides internship opportunities for eligible minority law students. Two paid (\$6,000) 10 week long summer internships will be awarded to deserving minority law students who will either be second or third year students in the fall of 2012. There are two participating programs this summer: the **York County Office of the Public Defender** and the **Law Firm of Griffith, Strickler, Lerman, Solymos & Calkins.** Both are located in York, Pennsylvania.

Students must be enrolled in law school full-time to qualify. Preference will be given to those applicants who are from Central Pennsylvania and who intend to practice law in Central Pennsylvania, with special preference given to those applicants who are from York County.

Applicants should send in the following materials: CNP DISP application, resume, cover letter, writing sample, and transcript. In their cover letters, applicants should rank the above internship programs in order of preference with one (1) being their first choice and two (2) being their second choice (if applying for both). In addition, applicants should note what ties, if any, they have to either York County or Central Pennsylvania. <u>If applying for the Griffith, Strickler, Lerman, Solymos & Calkins position, please also provide two (2) recommendations from law school professors.</u>
