**Commonwealth v. Ricky Clark****No. CP 22 -CR-0000711-2022****Criminal/Motion to Dismiss/Pennsylvania Firearm Prohibition Statute/ *Bruen***

1. At the time of Defendant's arrest on charges of Possession of Firearms Prohibited, 18 C.S. § 6105 A1, Defendant was subject to a Protection from Abuse Order which prohibited his possession of a firearm. Defendant had a prior conviction of the charge of Escape, 18 § 5121 §§ A , a felony of the third degree.
2. Defendant sought dismissal of the charge of Possession of Firearms Prohibited based upon the United States Supreme Court's analysis in *New York State Rifle & Pistol Ass'n, Inc. v. Bruen or Range v. Attorney General of the United States*, 69 F. 4<sup>th</sup> 96 (3d. Cir. 2023).
3. The Trial Court concluded that the Supreme Court in *Brunen* did not address the presumptive validity of a statute which prohibits a felon from possessing a firearm and, therefore, found it unnecessary to analyze whether Defendant, a convicted felon, is within the class of persons historically protected by Second Amendment.

Further no Pennsylvania appellate court has concluded that firearms regulations, including 18 Pa.C.S. § 6105, are unconstitutional under *Bruen*. See, *Commonwealth v. McIntyre*, 2024 WL 1245688, No. 354 EDA 2023, argued January 9, 2024, Filed March 25, 2024, Reargument Denied May 29, 2024 and *Commonwealth v. Nieves-Crespo*, No. 980 MDA 2023, 2024 WL 2239582, at \*13 (Pa. Super. Ct. May 17, 2024).

4. Because *Bruen* does not apply under the present state of Pennsylvania law, the Court denied Defendant's Motion to Dismiss.

MEMORANDUM OPINION AND ORDER

This matter comes before the court on a Motion of Ricky Clark ("Defendant") to Dismiss. For the reasons set forth, we DENY Defendant's Motion.

RELEVANT FACTUAL BACKGROUND

By way of criminal history which preceded the instant charges, On October 18, 2018, the Court, by the Honorable Deborah Curcillo sentenced Defendant at Dockets 3888 CR 2015 to a term of incarceration of not less than six nor more than twelve months on charges of Simple Assault <sup>1</sup> and Recklessly Endangering Another Person <sup>2</sup> . On the same date, the Honorable Deborah Curcillo sentenced Defendant at Docket Number 4958 CR 2017 on the

charge of Escape <sup>3</sup>, a felony of the third degree, to a term of incarceration of not less than one nor more than two years. At the time of the arrest in the instant case, Defendant was subject to a Protection From Abuse Order effective May 26, 2021 through May 26, 2024. <sup>4</sup>

On February 4, 2022, the Commonwealth charged Defendant with Possession of a Firearm Prohibited <sup>5</sup>, Receiving Stolen Property <sup>6</sup>, Manufacture, Delivery, or Possession With Intent to Manufacture or Deliver <sup>7</sup>, Intent to Possess Controlled Substance <sup>8</sup>, Marijuana - Small Amount Personal Use <sup>9</sup>

Defendant filed the instant Motion to Dismiss on September 18, 2023. We conducted a hearing on November 30, 2023. Following the filing of the transcript on April 11, 2024, the parties filed memoranda of law and pursuant to the Court's Order.

#### DISCUSSION

We decline to find that the United States Supreme Court's analysis in *New York State Rifle & Pistol Ass'n, Inc. v. Bruen* or *Range v. Attorney General of the United States*, 69 F. 4<sup>th</sup> 96 (3d. Cir. 2023), require us to find Pennsylvania's firearm prohibition statute, 18 Pa. C.S.A. §6105 unconstitutional.

In *Bruen*, the United States Supreme Court announced the test whereby statutes implicating the Second Amendment would only pass muster if the regulation is consistent with the United States' historical tradition of firearm regulation. The Supreme Court explained:

... when the Second Amendments plain context covers an individual's conduct, the Constitution presumably protects that conduct. To justify its regulation, the government may not simply posit that the regulation promotes an important interest. Rather, the government must demonstrate that the regulation is consistent with this Nation's historical tradition of firearm regulation. Only if a firearm regulation is consistent with the Nation's historical tradition may a court conclude that the individual's conduct falls outside the unqualified command.

*Bruen*, 142 S.Ct. at 2126.

*Bruen*, a civil case, addressed the Second Amendment rights of “ordinary law-abiding citizens” with respect to New York’s regulations as to the state’s license to carry system. The Supreme Court stated:

New York’s proper-cause requirement violates the Fourteenth Amendment in that it prevents law-abiding citizens with ordinary self-defense needs from exercising their right to keep and bear arms.

*Bruen*, 142 S.Ct. 2111, 2156 (2022).

Under the *Bruen* analysis, a Court reviewing any law impinging on the citizenry’s Second Amendment rights must “determine whether modern and historical regulations impose a comparable burden on the right of armed self-defense and whether that burden is comparably justified. *Id.* at 2132 (citations omitted). The Court must determine whether modern and historical regulations impose a comparable burden on the right of armed self-defense and whether that burden is comparably justified. *Id.*

The Supreme Court’s analysis in *Bruen* Court’s considered the question of Second Amendment rights of “ordinary, law-abiding citizens.” *Id.*, at 2122. Historically, the right to bear arms does not extend to those who have committed felonies. In *District of Columbia v. Heller*, 554 U.S. 570 (2008), the United Justice Scalia stated:

Like most rights, the right secured by the Second Amendment is not unlimited...[N]othing in our opinion should be taken to cast doubt on long-standing prohibitions on the possession of firearms by felons and the mentally ill, or laws forbidding the carrying of firearms in sensitive places such as schools and government buildings, or laws imposing conditions and qualifications on the commercial sale of arms.

*Id.*, at 626-27.

The *Heller* Court noted, “[w]e identify these presumptively regulatory measures only as examples; our list does not purport to be exhaustive.” *Id.*, at 627, n. 26. Again, in *McDonald v. City of Chicago*, 561 U.S. 742 (2010), the Supreme Court stated, “[w]e repeat those assurances here.” *Id.*, at 786. Notably, the Supreme Court in *Brunen* did not abrogate the language of *Heller* and *McDonald* nor did it address the presumptive validity of a statute which prohibits a felon from possessing a firearm. We find it unnecessary to analyze whether Defendant, a convicted felon, is within the class of persons historically protected by Second Amendment.

Nor are we bound by the decision of the United States District Court which dismissed Defendant’s federal indictment on the charge of prohibited possession of a firearm based

upon *Range*. "It is well-established that the holdings of the Third Circuit are not binding upon this Court, even in the context of a question of federal law. See *Werner v. Plater-Zyberk*, 799 A.2d 776, 782 (Pa.Super. 2002) ("[A]bsent a United States Supreme Court pronouncement, the decisions of federal courts are not binding on Pennsylvania state courts, even when a federal question is involved.") *Galette v. NJ Transit*, 2023 PA Super 46, 293 A.3d 649, 655-56 (2023), reargument denied (May 30, 2023), appeal granted in part, No. 204 EAL 2023, 2024 WL 617350 (Pa. Feb. 14, 2024)

Further, this Court has found 18 Pa. C.S.A. §6105 presumptively constitutional. In *Farmer*, CP-22-CR-4742 -2020 (July 20, 2023), sitting *en banc*, we considered whether we are bound by *Range v. Attorney General of the United States*, 69 F. 4<sup>th</sup> 96 (3d. Cir. 2023), which held that the Federal felon-in-possession statute, 18 U.S. §922 (g)(1) violates the Second Amendment under the *Bruen* Analysis. *Range*, 69 F. 4<sup>th</sup> at 106. In *Farmer*, the defendant filed a Post-Sentence Motion for Arrest of Judgment following his conviction of Persons Not to Possess Firearms. Defendant asserted that 18 Pa.C.S. § 6105 is facially unconstitutional and unconstitutional as applied to him under the Second Amendment of the United States Constitution and Article I, Section 21 of the Pennsylvania Constitution. The majority of this court in *Farmer* was "unpersuaded that *Range* correctly applies *Bruen* or that *Bruen* renders § 6105 unconstitutional as to Farmer, or to any future defendant until such time as a court of higher authority holds differently. *Farmer*, at 3. The undersigned, in an Opinion Concurring in the Result, concluded that the holding in *Range* was explicitly narrow and not applicable to Farmer's case. We reasoned that "[a] statute is presumed constitutional and will not be declared unconstitutional unless it 'clearly, palpably and plainly' violates the Constitution. All doubts are therefore to be resolved in favor of a finding of constitutionality." Opinion Concurring in the Result, pp 1-2, citing *Commonwealth v. Craven*, 817 A.2d 451, 454 (Pa. 2003).

Finally, Defendant's reliance upon *New York State Rifle & Pistol Ass'n, Inc. v. Bruen* or *Range v. Attorney General of the United States*, 69 F. 4<sup>th</sup> 96 (3d. Cir. 2023) as a basis for relief lacks merit in that no Pennsylvania appellate court has concluded that firearms regulations, including 18 Pa.C.S. § 6105, are unconstitutional under *Bruen*. See, *Commonwealth v. McIntyre*, 2024 WL 1245688, No. 354 EDA 2023, argued January 9, 2024, Filed March 25, 2024, Reargument Denied May 29, 2024 and *Commonwealth v. Nieves-Crespo*, No. 980 MDA 2023, 2024 WL 2239582, at \*13 (Pa. Super. Ct. May 17, 2024). *Bruen* does not apply under the present state of Pennsylvania law.

Here, Defendant was subject to an Order which ordered him to relinquish all weapons and not to possess them. We find no basis on which to conclude that the Court lacked constitutional authority to do so.

Accordingly, we enter the following:

**ORDER**

AND NOW, this 28<sup>th</sup> day of August, 2024, it is hereby ORDERED that:

Defendant's Motion to Dismiss is DENIED.
