Appeal of Chester County Outdoor

Billboard - Health, safety and welfare of public

In its Decision of July 8, 2020, this Court determined that the proposed billboard in the location selected would pose risk to the health safety and welfare of the public. Consistent with that determination, the court sought to consider alternative sites or configurations for the proposed billboard. A subsequent submission reconfigured and moved the billboard. The Township had the burden to prove its position that the new-ly proposed configuration had an adverse impact on the public's health, welfare and safety. The newly proposed billboard was not in the line of sight through the traffic signal; the intersection had been reconfigured, making it safer; the Township's expert could not determine what effect the billboard would have on accidents. The Court *Held* the Township did not meet its burden regarding the newly proposed billboard. Accordingly, the appeal of Chester County Outdoor, LLC was granted, approving the proposed billboard and submitted plan presented to the court.

DECISION

Appellant, Chester County Outdoor LLC ("CCO"), is in the business of developing and operating outdoor advertising assets. In 2011, CCO filed a substantive validity challenge to Sections 1902.13 and 1904.1 of the Zoning Ordinance of Appellee, East Pikeland Township (the "Township"), alleging that the provisions unlawfully excluded off-site advertising, i.e., billboards. The Zoning Hearing Board in 2012 issued a decision and order sustaining the validity challenge. Extensive litigation ensued following the denial of CCO's permit application which it submitted in 2016. CCO first appealed to this court, which denied its appeal from the ZHB's decision. CCO then appealed this court's denial to the Commonwealth Court.

In its Opinion and Order of July 28, 2017, the Commonwealth Court concluded that CCO was entitled to site-specific relief. It remanded the matter to the trial court and directed that this court review CCO's application in accordance with their noted directives. The trial court did so and issued a Decision and Order on July 8, 2020 consistent with the Commonwealth Court's directive. In sum, the trial court concluded as follows:

- 1. The Township met its burden of demonstrating that the proposed billboard failed to comply with the extant provisions of the 2011 ordinance;
- 2. The unchallenged pre-existing and generally applicable provisions of the Zoning Ordinance nonetheless could not be applied to CCO's application: and
- 3. The Township met its burden and demonstrated that the proposed billboard would pose a risk to the health, safety and welfare of the public. Specifically, the court identified concerns regarding visual lines for drivers and traffic conditions at the proposed location.
- The court therefore needed to consider alternative sites or alternative 4. configurations for the proposed billboard in order to fashion site-specific relief.

In accordance with the trial court's findings and conclusions, additional hearings

were scheduled to consider appropriate site alternatives or configurations. The trial court held additional hearings on December 18, 2020, April 4, 2021 and May 17, 2021. Based upon the evidence presented, the court makes the following:

I. FINDINGS OF FACT

1. At the December 18, 2020 hearing, CCO presented a new proposal for its billboard. The billboard is to be located at 458 Schuylkill Road, PA Route 23 (the "Property").

2. Schuylkill Road/Route 23 is an urban arterial roadway. (Exhibit T-7 (4/7/2021), at p. 2).

3. The speed limit on the road at the proposed billboard site is 45 miles per hour. (N.T., 11/21/19, 71:15-17).

4. The Property (Tax Parcel I.D. #: 26-3E-21.1) is in the Township's Mixed Use ("MU") Zoning District. (Exhibit T-8).

5. The proposed location for the billboard is the west side of Schuylkill Road (Route 23), on the northern side of the Property. (N.T., 11/21/19, at 12:9-14, N.T., 12/18/20, 12:11-13).

6. This new location is approximately 230 feet north of the prior proposed location. (Exhibit A-1 (12/18/2020)).

7. There are no residences within 150 feet of the proposed billboard. (N.T., 4/7/21, at 82, 83).

8. The proposed billboard has two faces. Each face is 27 feet tall by 18 feet wide. (Exhibit A-1 (12/18/2020)).

9. The proposed billboard is a monopole of the same structure as the prior proposed pole. (Exhibit A-1 (12/18/2020)).

10. The height of the billboard structure is 48 feet, the same as the prior proposed billboard. (Exhibit A-1 12/18/2020).

11. The prior proposed billboard was wider than it was high. (Exhibit A-1 12/18/2020).

12. The present proposed billboard is taller than it is wide. (Id.)

13. CCO has rotated the billboard so that the long side is the vertical side. (*Id.*)

14. Subsequent to the proceedings before the Zoning Hearing Board, the area of the proposed billboard, Route 23, underwent significant roadway improvements.

15. The improvements included the creation of a center turn lane and a realignment of the intersection of Rt. 23 and Rt. 724. (N.T., 4/7/2021, at pp. 6-7).

16. The proposed billboard does not align with the traffic signal at Rt. 724 and Rt. 23. (N.T. 12/18/2020 p. 12-20, 35).

17. The reconfiguration removed the proposed billboard from the line of sight through the traffic signal at Rt. 23 and Rt. 724.

18. The proposed billboard will operate and function in compliance with the PennDOT standards. (N.T. 12/18/2020 p. 17-20).

19. The proposed billboard will project light in the same directed manner as the previously proposed billboard. It will not project any foot candles of illumination to any residential property. (N.T. 12/18/2020 p. 19-20).

20. The pre-reconfiguration crash data for the Snyder Avenue and Rapps Dam Road ("Snyder/Rapps Dam") segment of the roadway was 78% higher than the average for similar urban minor arterial roads in the Commonwealth.

21. The only year of traffic statistics available for evaluation of accident projection for this traffic, other than the COVID impacted year of 2020, is 2019. (N.T., 5/17/2021, at p. 13).

22. The Township's traffic witness was Joseph Fiocco ("Fiocco"). He presented a safety study based on an analysis that included use of the Highway Safety Manual ("HMS") method of analysis to project accidents in the Snyder/ Rapps Dam corridor. (N.T., 4/7/2021, at p. 9).

23. The HMS enables traffic safety analysts to quantify the number of crashes that will be expected based on an evaluation of the various characteristics of the road, such as driveway density, lanes and similar criteria. (N.T., 4/7/2021, at pp. 9-11).

24. Fiocco presented an HMS analysis that predicted 14.83 crashes/yr in the Snyder/Rapps Dam corridor. (Exhibit T-7).

25. Fiocco did not perform an HSM analysis or corridor evaluation on the commercial district where the Township permits billboards by special exception to compare predicted crashes/yr. against the Snyder/Rapps Dam corridor. (N.T 4/7/21 p. 37-39).

26. In 2019, there were 9 crashes in the Snyder/Rapps Dam corridor, none of which were rear-end accidents in the road segments between intersections. (Exhibit T-7; N.T., 5/17/21, at p. 8).

27. Because the actual crashes/yr were less than the predicted crashes/ yr, the HSM methodology adjusts the predicted crashes/yr downward to reach an "expected average crash frequency," in this case adjusting from 14.83 crashes/yr to 10.77 crashes/yr. (Exhibit T-7).

28. The downward adjustment reflects that the Snyder/Rapps Dam segment actually operates safer than expected with the new road improvements. (Exhibit T-7).

29. The inclusion of a digital billboard as proposed would not adjust the predicted or expected crashes/yr in the HSM analysis; it is not a factor considered by the HSM methodology. (N.T. 5/17/2021 p. 5).

30. Only 15% of people injured in traffic accidents nationally are injured in accidents caused by distractions. (N. T. 4/7/2021 p. 33, 34).

31. Applying that average to the 9 accidents in the Snyder/Rapps Dam corridor in 2019, only 2 of which involved injury, none, or at most one, of the accidents would have been caused by distractions. (N.T. 4/7/2021 p. 33, 34; Exhibit T-7).

32. Fiocco testified, however, that billboards are not needed and intro-

duce one more potential distraction risk and would not be recommended at this location by him. (N.T., 4/7/2021, at pp. 13, 36).

II. DISCUSSION

In its Decision of July 8, 2020, this Court determined that the proposed billboard in the location selected would pose a risk to the health safety and welfare of the public. Consistent with that determination, the court sought to consider alternative sites or configurations for the proposed billboard. CCO, in turn, modified its billboard proposal. Those modifications were submitted to the court for its consideration.

The Township continues to oppose the newly proposed configuration. It argued the new proposal still would have an adverse impact on the public's health, welfare and safety. It remained the Township's burden to demonstrate the same. It did not meet its burden with regard to the new proposal.

Initially, the court found the property unsuitable for the proposed billboard because the signage would align with the Rt. 23/Rt. 724 traffic signal for southbound drivers on Rt. 724. It further concluded that the pre-2018 traffic improvement data indicated that the road corridor between Snyder Avenue and Rapps Dam Road had a higher-than-average crash rate. As a result of the court's conclusions, CCO reconfigured the billboard and its proposed location. It moved the billboard to the northern end of the property. It rotated the billboard's display such that the long side is the vertical side. The reconfiguration removed the proposed billboard from the line of sight through the traffic signal at Rt. 23 and Rt. 724. The court's first concern has been alleviated.

The other adverse impact on public safety and welfare previously found by the court was traffic safety. The testimony prior to the 2018 reconstruction of the roadway corridor was that pre-reconfiguration crash data for the Snyder/Rapps Dam segment indicated a 78% higher than the average crash rate (for similar urban minor arterial roads in the Commonwealth). Although the Township again asserts that the inclusion of this billboard at the selected location introduces a distraction risk that would create an unacceptable impact on public safety, the record no longer supports the Township's beliefs.

The 2018 highway improvements have substantially improved the safety of the corridor. With the center left turn and refuge lanes, there have been no non-intersection accidents, whether rear-end or otherwise, in 2019, the year of data available since the construction of the improvements. Accidents are so reduced in the corridor that the numbers fall below the Highway Safety Manual predicted number of accidents, being less than 61% of the predicted total. Instead of being a higher-than-average crash rate corridor, the evidence demonstrated that this segment now operates below HSM predictions. As for the Township's argument that distractions can cause accidents and the billboard is a distraction, the Township witness testified that: a) only 15% of traffic accident injuries nation-wide occur in accidents resulting from distraction; b) billboards do not have an input factor for

the HSM calculation of accident predictability but other uses like driveways, restaurants and bars do; c) there is no method for determining the increase, if any, that the introduction of a billboard would have on accidents on the abutting roadway.

The court, therefore, will approve the relief requested by CCO.

III. CONCLUSIONS OF LAW

1. The newly proposed billboard alleviates the court's concerns regarding visual lines for drivers and traffic conditions at the proposed intersection.

2. The Township did not meet its burden of demonstrating that the newly proposed billboard would pose a risk to the health, safety and welfare of the public.

3. CCO is entitled to the relief requested and approval of their newly configured billboard at the revised location.
