#### OPINION AND ORDER DENYING MOTION FOR PROTECTIVE ORDER

Plaintiff filed a Motion for Protective Order on April 8, 2013 seeking to prevent Counsel for Defendants from communicating *ex parte* with Plaintiff's Decedent's subsequent treating physicians: K. Michael Hughes, D.O., Larry Shears, M.D., Clifford Lynd, M.D. and Percival Buenaventura, M.D. In the Motion, Plaintiff argues that the treating surgeons are not employees, or ostensible employees, of Defendants York Towne Urology or York Hospital because their treatment of the Decedent was not related to or relevant to the treatment that gave rise to this medical malpractice action. Complications arose during a laparoscopic procedure conducted by Defendants Edgar C. Baselli, M.D. and Clyde A. Strang, M.D. which necessitated surgery. The subsequent treating physicians were called in to perform that surgery. The Decedent ultimately survived and was discharged home.

Defendants filed a Response and Brief in Opposition to the Motion for Protective Order on May 1, 2013. Argument was held on the matter at the May 2, 2013 session of Current Business, at which time the Court took the matter under advisement.

Pa. R. Civ. Pro. No. 4003.6 provides that "[i]nformation may be obtained from the treating physician of a party only upon written consent of that party or through a method of discovery authorized by this chapter." However, an attorney can speak informally with a treating physician if that treating physician is the attorney's client, an employee of the attorney's client, or an ostensible employee of the attorney's client. The present issue concerns the question of whether the treating surgeons are employees or ostensible employees of York Hospital and/or York Towne Urology.

The subsequent treating physicians in this case are employees WellSpan Medical Group, which, with York Hospital, is owned by WellSpan Health. Defendants argue that since the subsequent treating physicians are not part of a private practice, not independent contractors, and are employees of the same organization as the Defendant Physicians, that they are *de facto* employees of York Hospital and clearly ostensible employees of York Hospital.

Plaintiff disagrees and refers the Court to Judge Nealon's Opinion in *White v. Behlke*, 2004 WL 1570095 (Pa.Com.Pl.), 65 Pa. D. & C. 479 (Lackawanna C.C.Pl. 2004), wherein Judge Nealon interprets Rule 4003.6 as only permitting informal communication with a subsequent treating physician where the treatment is related to or relevant to the treatment giving rise to the plaintiff's cause of action. Plaintiff argues that the subsequent treating physicians' treatment of the Decedent in this case was not related to or relevant to the allegedly negligent laparoscopic procedure giving rise to the medical malpractice action.

The background and history of Rule 4003.6 is fully covered in Judge Nealon's Opinion and the Court will not retread the path he has so astutely covered. The Court is also highly persuaded by Judge Nealon's interpretation of Rule 4003.6. In *White*, the subse-

quent treating physician cared for the Plaintiff during her second pregnancy, but the underlying medical malpractice case concerned Plaintiff's first, and unrelated, pregnancy. In the present case, the subsequent treating physicians were involved in the actual surgery giving rise to this case. Plaintiff argues that the actions of the treating surgeons are not at issue in this case; however, this does address the question of whether the treatment was related to the allegedly negligent treatment. The treating physicians were called in to the surgery immediately after the Defendant Physicians encountered complications, the treating surgeons were then involved in the nine hour surgery to repair the Plaintiff, and the Defendant Physicians remained present for the majority of the surgery. Unlike White, there was no new and discreet treatment occurring at some point after the treatment giving rise to the cause of action; the treatment in this case was directly related to the medical malpractice claim. In conclusion, the Court will DENY the Motion for Protective Order filed on April 8, 2013.

#### ORDER DENYING MOTION FOR PROTECTIVE ORDER

AND NOW, this 24th day of May 2013, in accordance with the above Opinion, the Motion for Protective Order filed by Plaintiff is **DENIED**.




