Petition to Disqualify Counsel

- 1. If a lawyer learns from a prospective client information which may be significantly harmful to that person, Rule of Professional Conduct 1.18 prevents the lawyer from representing a client with interests materially adverse to those of that prospective client in the same or a substantially similar matter. There is no exception except where the prospective client has given informed consent.
- 2. Defendant argued that it would be efficient for this court to first decide the preliminary objections because, if granted, that would moot plaintiff's Petition to Disqualify. The Court rejected defendant's argument that legal representation that violates Rule of Professional Conduct 1.18 is nevertheless permitted so long as it avoids use of information obtained from a prospective client which may be significantly harmful to that person. Via the Rule, representation of the client, itself is prohibited. Upon consideration of the Petition of Plaintiff to Disqualify Counsel for Defendant and to Stay Action Pending Determination of the Petition, it was ordered that the case was stayed in all respects, except for those pertaining to the Petition of Plaintiff to Disqualify Counsel for Defendant.

AND NOW, this 22nd day of February, 2022, upon consideration of the Petition of Plaintiff to Disqualify Counsel for Defendant and to Stay Action Pending Determination of the Petition, filed December 9, 2021, Defendant Debra Foglietta's Response, and Plaintiff's Sur Reply, for the reasons set forth in the accompanying Memorandum, it is hereby **ORDERED** that this case is **STAYED** in all respects, except for those pertaining to the Petition of Plaintiff to Disqualify Counsel for Defendant.

MEMORANDUM

A lawyer might learn from a prospective client information which may be significantly harmful to that person. Rule of Professional Conduct 1.18(b). If so, then that the lawyer cannot represent a client with interests materially adverse to those of that prospective client in the same or a substantially similar matter. Rule of Professional Conduct 1.18(c). There is no exception except where the prospective client has given informed consent. Rule of Professional Conduct 1.18(d)(1).

Here, Plaintiff asked this court to enter a stay until this court decides Plaintiff's Petition to Disqualify. *See* Petition, 12/9/2021, ¶ 49. Plaintiff argued this court should do so to safeguard the integrity of the judicial system and the interests of justice. Sur Reply, 2/4/2022, p. 2. Defendant Foglietta argued that it would be efficient for this court to first decide the Preliminary Objections she filed on September 10, 2021 because they ask this court to dismiss the Complaint which would moot Plaintiff's Petition to Disqualify. *See, e.g.*, Response, 1/25/2022, ¶¶ 6, 14-15, 22. Defendant Foglietta argued that her Preliminary Objections can be decided first because they rely on the face of the Complaint, and facts of public record, and thus the facts of the Preliminary Objections stand apart from the facts Plaintiff alleged in her Petition to Disqualify. *See, e.g.*, Response, 1/25/2022, ¶¶ 20-21.

This court rejects Defendant's argument and its implication that a legal representation that violates Rule of Professional Conduct 1.18 is nevertheless permitted so long as it avoids use of information obtained from a prospective client which may be significantly harmful to that person. Rule of Professional Conduct 1.18 contains no such exception. This court believes that Plaintiff's position and request for a stay is consistent with Rule of Professional Conduct 1.18 because it is the representation of the client, itself, that is prohibited. Deciding the Preliminary Objections first would risk continued violation of Rule of Professional Conduct 1.18 and continued harm to Plaintiff thereby. This court must choose Plaintiff's interest in minimizing the risk of harm and continued violation of Rule of Professional Conduct 1.18 over Defendant Folgietta's interest in economy. Given the seriousness of Plaintiff's allegations, this court believes it is better to err on the side of caution consistent with this court's supervisory responsibilities.

Accordingly, this court will enter an order staying this case in all respects, except for those pertaining to the Petition of Plaintiff to Disqualify Counsel for Defendant.
