Pre-judgment interest

- Pre-judgment interest can be due under the following two scenarios: (a) if the
 breach consists of a failure to pay a definite sum in money, interest is recoverable
 from the time for performance on the amount due less all deductions to which the
 party in breach is entitled; or (b) in any other case, such interest may be allowed as
 justice requires on the amount that would have been just compensation had it been
 paid when performance was due.
- 2. Under the first option, a party is not chargeable with interest on a sum unless its amount is fixed by the contract or he could have determined its amount with reasonable certainty so that he could have made a proper tender.
- 3. The sum due is sufficiently definite if it is ascertainable from the terms of the contract.
- Before awarding pre-judgment interest, the court must identify the nature of the breach.
- 5. The justification for an award of pre-judgment interest is that because the defendant knew or at least could have learned the amount of his debt, he should have tendered that amount to the plaintiff.
- 6. Failing to tender the money deprives the plaintiff of the use of that amount from the date of the breach to the date of the satisfaction of the judgment.
- 7. Where the amount due and owing is not sufficiently definite, prejudgment interest is awardable at the discretion of the trial court.
- 8. The court must consider whether the fault for nonpayment rests with the defendant or the plaintiff.
- Pre-judgment interest is not the rule, but the exception and may be allowed only as necessary to ensure that in the particular circumstances of the case, the plaintiff has been fully compensated.
- 10. The complaint alleged a breach of contract via an oral agreement establishing a partnership or, alternately, an oral agreement to share revenue. The jury found in favor of Plaintiff on the latter claim. Plaintiff filed a motion seeking this Court to mold the jury verdict to include pre-judgment interest dating from the alleged breach of contract through the date of verdict. Under the breach of an agreement to share revenue theory, Plaintiff's expert stated that the amounts due to Plaintiff were \$128,456.00, not the \$102,000.00 the jury found as the amount due and owing. Given that Plaintiff herself could not ascertain the monies found to be owed, this Court declines to state that Defendants knew a fixed ascertainable amount at the time of the breach. In this case, the sum was uncertain and no proper tender could be made. Plaintiff rejected Defendants' tender of 67% of the sum ultimately found to be owing. Justice does not require pre-judgment interest. The Court *Held* Plaintiff's Motion to Mold the Verdict to Include Pre-Judgment Interest was denied.

MEMORANDUM

Plaintiff moves this court to mold the jury verdict entered in her favor in the amount of \$102,000.00 to include pre-judgment interest dating from the alleged breach of contract, May 14, 2019, through the date of verdict on July 21, 2023. For the reasons that follow, this court denies the Motion.

As brief background, Plaintiff filed a complaint against Direct Link Marketing, LLC (DLM) and Daphne Howard (collectively, "Defendants") for breach of contract via an oral agreement establishing a partnership or, alternately, an oral agreement to share revenue. The jury ultimately found in favor of Defendants on the claim of a partnership but in favor of Plaintiff on the claim for breach of an oral contract to share revenue.

Pennsylvania has adopted the Restatement (Second) of Contracts, § 354 with respect to pre-judgment interest. <u>Cresci Const. Servs., Inc. v. Martin</u>, 64 A.3d 254 (Pa. Super. 2013); <u>see also Fernandez v. Levin</u>, 548 A.2d 1191 (Pa. 1988) (adopting Section 354). The Restatement provides two scenarios in which pre-judgment interest is due:

- (1) If the breach consists of a failure to pay a definite sum in money . . . interest is recoverable from the time for performance on the amount due less all deductions to which the party in breach is entitled.
- (2) In any other case, such interest may be allowed as justice requires on the amount that would have been just compensation had it been paid when performance was due.

Restatement (Second) of Contracts § 354.

Turning first to subsection (1), the question hinges on whether or not a definite sum of money was due. The comment to Section 354 clarifies that pursuant to "[s]ubsection (1), a party is not chargeable with interest on a sum unless its amount is fixed by the contract or he could have determined its amount with reasonable certainty so that he could have made a proper tender. . . . The sum due is sufficiently definite if it is ascertainable from the terms of the contract[.]" <u>Id.</u> at comment c (emphasis added). Accordingly, "before awarding prejudgment interest, the court must identify the nature of the breach." <u>Cresci</u>, supra, 64 A.3d at 258.

In Frank B. Bozzo, Inc. v. Electric Weld Div. of Fort Pitt Div. of Spang Industries, Inc., 498 A.2d 895, 898 (Pa.Super. 1985), the Superior Court laid out the rationale for awarding pre-judgment interest: "The justification for an award of prejudgment interest is that because the defendant knew or at least could have learned the amount of his debt, he should have tendered that amount to the plaintiff." The Bozzo Court further reasoned that failing to tender the money "deprive[s] the plaintiff of the use of that amount from the date of the breach to the date of the satisfaction of the judgment." Id.; see also Cresci, supra, 64 A.3d at 263-64 (quoting Bozzo).

Presently, a dispute exists regarding the jury award of \$102,000.00 for breach of contract. Specifically, whether or not the amount was a definite sum of money that was ascertainable from the terms of the contract. Here, there is no written contract to examine; however, the jury, over the course of a five-day trial, were presented extensive evidence and testimony regarding the historical share of revenues as well as the underlying financial data. Moreover, experts for each party laid out their review of the tax returns of the parties. Ultimately, the jury found that there was a contract and that the sum due was \$102,000.00.

Interestingly, and of note here, Plaintiff's expert (under the ultimately prevailing theory of a breach of an agreement to share revenue) stated that the amounts due to Plaintiff were \$128,456.00. At no point did Plaintiff or her experts claim that \$102,000.00 was the amount due and owing. Given that Plaintiff herself could not ascertain the monies found to be owed, this court declines to state that Defendants knew at the time of the breach a fixed ascertainable amount. See Restatement (Second) of Contracts §354 cmt. C ("a [defendant] is not chargeable with interest on a sum unless its amount is fixed by the contract or he could have determined its amount with reasonable certainty so that he could have made a proper tender."). See also Davis v. Borough of Montrose, 194 A.3d 597, 614 (Pa.Super. 2018) (opining that pre-judgment interest must be recovered as of right only if, inter alia, the "defendant commits a breach of contract to pay a definite sum of money."). Here, the sum was uncertain and no proper tender could be made. As discussed further below, Defendants in fact made a tender of 67% of the sum ultimately found to be owing in an effort to determine the amount due – Plaintiff's calculations were approximately 26% higher than the amount awarded. The evidence at trial made clear that Plaintiff was paid variable amounts with variable expenses deducted both with and without her knowledge. Neither party properly estimated or could ascertain the amounts due and in fact, both missed the jury's determination by 26-33%. Given this lack of certainty, Plaintiff is not entitled to prejudgment interest on the full \$102,000.00 as a matter of right pursuant to Section 354(1) as no sufficiently definite amount was due and owing.

This court now turns its attention to subsection (2) of Section 354 to determine if "justice requires [interest] on the amount that would have been just compensation had it been paid when performance was due." Restatement (Second) of Contracts §354(2). In particular, "[w]here the amount due and owing is not sufficiently definite, prejudgment interest is awardable at the discretion of the trial court." Century Indemnity Company v. OneBeacon Insurance Company, 173 A.3d 784 (Pa.Super. 2017) (citing (Ely v. Susquehanna Aquacultures, Inc., 130 A.3d 6, 15 (Pa.Super. 2015)). Although the full \$102,000.00 could not be readily determined from the agreement between the parties, could some portion be determined as due and owing? Does justice require payment of some pre-judgment interest?

In this case, matters are complicated by a payment attempted by Defendants. Specifically, this court at trial admitted into evidence a letter sent on May 14, 2019 by Defendants' counsel to Plaintiff's counsel including a check for \$68,391.70 representing Plaintiff's "share of revenue received by [DLM] since December 28, 2018, for work performed prior to that date[.]" Exhibit P-109 (5/14/19 Letter). The

letter further detailed the accounts to which monies were being paid. Plaintiff testified she did not cash the check and argues that to do so would have exposed her to a claim that Defendants had paid in full satisfaction of amounts owed. This court notes that the 5/14/19 Letter does not include any language concerning the payment to be in satisfaction of any claim or lawsuit or that retaining the funds would be deemed as full accord and satisfaction.1

This court finds that Defendants were aware and could ascertain that at least \$68,391.70 was due under Defendants' interpretation of the agreement for revenue sharing found by the jury. However, this court will not impose pre-judgment interest when Plaintiff received a check for that amount relatively soon after Defendants received payments from the individual accounts cited in P-109. See also USI Ins. Servs. Nat'l Inc. v. Frieman, 273 A.3d 1039 (Pa.Super. 2022) ("[T]he court must consider whether the fault for nonpayment rests with the defendant or the plaintiff."). Here, Plaintiff rejected the \$68,391.70 payment and the fault for non-payment of this amount rests with her. As such, justice does not require pre-judgment interest on this amount.

Taking the jury award of \$102,000.00 less the \$68,391.70 ascertained by Defendants and proffered, leaves \$33,608.30. This court has discretion in awarding pre-judgment interest pursuant to Section 354(2); however, such discretion is limited to where justice requires it. The Pennsylvania Superior Court has noted that pre-judgment interest "is not the rule, but the exception and may be allowed only 'as necessary to ensure that in the particular circumstances of the case, the plaintiff has been fully compensated." Helpin v. Trustees of University of Pennsylvania, 969 A.2d 601, 620 (Pa.Super. 2009) (quoting Bozzo, supra, 498 A.2d at 899).

Presently, this court finds: (1) the amount of damages claimed were, at best, difficult to determine; (2) Defendants issued a payment greater than two-thirds of the ultimate amount found to be owing; (3) Plaintiff could not accurately determine the amount due; and (4) Plaintiff caused much of the delay in receiving an ultimate judgment due to a substitution of counsel in July of 2022 and a request for continuance of a date certain trial scheduled for March 20, 2023. Justice does not dictate prejudgment interest on the \$33,608.30 found to be owed by the jury in addition to Defendants' previously calculated and proffered \$68,391.70.

Accordingly, for the reasons set forth above this court will enter an order denying Plaintiff Susan Butterworth's Motion to Mold the Verdict to Include Pre-Judgment Interest filed July 27, 2023.

¹ It was on this basis that this court determined this letter within P-109 did not warrant exclusion pursuant to Pa.R.E. 408 (precluding offers of compromise and negotiation) as nothing within the letter itself suggested it was motivated by or in furtherance of a settlement. Rather, it was payment of funds as calculated by Defendants as due and owing pursuant to Plaintiff's interpretation of their agreement that Plaintiff should be paid on revenues attributable to her time working with DLM but post-dating her 12/28/2019 separation from DLM. This court did exclude the response letter referencing the lawsuit (at that point merely a writ of summons) and dispute between the parties. It is further noted by this court that Plaintiff offered P-109 at trial on the basis that it was not a Rule 408 settlement offer and cannot now argue that it was a settlement attempt that should not be considered a genuine proffer of funds by Defendants to Plaintiff.
