FINAL DECREE

AND NOW, this 18th of May, 2022, upon consideration of the Petition for Involuntary Termination of the Parental Rights of Juan Luis Salmeron, a/k/a Luis Salmeron, as natural father of I.J.S., a minor, and after hearing held thereon, the Court concludes the following which have been established by clear and convincing evidence as set forth in the findings entered concurrently herewith.

1. This Court has jurisdiction over this matter;

2. Notice of the hearing on the petition for involuntary termination was provided to Juan Luis Salmeron, a/k/a Luis Salmeron and to all persons entitled to notice;

3. Juan Luis Salmeron, a/k/a Luis Salmeron, the natural father of I.J.S., by conduct continuing in excess of six (6) months, has evidenced a settled purpose of relinquishing parental claim to the child, and has failed to perform parental duties;

4. The repeated and continued incapacity, abuse, neglect or refusal of Juan Luis Salmeron, a/k/a Luis Salmeron has caused I.J.S. to be without essential parental care, control or subsistence necessary for his physical or mental well-being and the condi-

tions and causes of the incapacity, abuse, neglect or refusal cannot or will not be remedied by Juan Luis Salmeron, a/k/a Luis Salmeron;

5. I.J.S. was removed from the care of Juan Luis Salmeron, a/k/a Luis Salmeron, natural father, by the court for a period of at least six (6) months; the conditions which led to the removal of the child continue to exist; Juan Luis Salmeron, a/k/a Luis Salmeron, cannot or will not remedy those conditions within a reasonable period of time; and, the services or assistance reasonably available to Juan Luis Salmeron, a/k/a Luis Salmeron, are not likely to remedy the conditions which led to the removal of the child within a reasonable period of time;

6. The termination of the parental rights of Juan Luis Salmeron, a/k/a Luis Salmeron is best for the developmental, physical and emotional needs and welfare of I.J.S.; and

7. The custody of I.J.S. is awarded to Schuylkill County Children & Youth Services, intermediary.

IT IS FURTHER ORDERED that the parent whose rights have been terminated is advised of his continuing right to place and update personal and medical history information, whether or not the medical condition is in existence or discoverable at the time of adoption, on file with the court and with the Department of Public Welfare pursuant to Subchapter B of Chapter 29.

It is directed that all papers in this case and the testimony shall be withheld from public inspection and no person shall be allowed access thereto except upon Order of this Court granted upon cause shown.
