Mitchell vs. Megill Homes, Inc., et al.

Rule to show cause

1. The filing of an amended complaint has the effect of eliminating the prior complaint.
2. C.C.R.C.P. 206.4(c)(1) states an order containing a rule to show cause, except one which by its terms grants substantive relief or which contains a stay order or seeks to require an answer by respondent(s) in less than twenty (20) days, shall be issued per curiam when presented to the court administrator.
3. C.C.R.C.P. 206.4(c)(2) provides the court may enter an order containing a rule to show cause in exceptional circumstances, such as when the court enters a stay or grants substantive relief.
4. On December 26, 2023, Defendants, Megill Homes, Inc. and Wayne C. Megill filed their Unopposed Petition to Release, Remove, and Strike Levies from Property. Petitioners averred that the parties agreed to settle this matter, Plaintiffs agreed to dissolve all garnishments, levies, and judgments against Misty Meadows, and Plaintiffs were in receipt of all settlement funds. Petitioners did not obtain a rule to show cause but filed a Praecipe for Determination for the Petition on January 17, 2024. On January 18, 2024, this Court dismissed the Praecipe for Determination without prejudice. This court noted Petitioners had not followed proper procedure to have their Petition granted as unopposed and explained that Petitioners should obtain the relief requested pursuant to C.C.R.C.P. 206.4(c)(1), pertaining to issuance of order containing a rule to show cause, C.C.R.C.P. 206.3, pertaining to service and certification of same, and C.C.R.C.P. 206.4(c)(4), pertaining to motion to make rule absolute and grant petition as unopposed. Nonetheless, on February 9, 2024, Defendants filed the Petition presently before this court, which is essentially the same as the Petition filed December 26, 2023, except Petitioners also requested this Court to enter a rule to show cause. This court noted that the Petition filed December 26, 2023 was withdrawn by the filing of the second Petition on February 9, 2024. The filing of the second Petition was unnecessary since this Court struck the first Praecipe for Determination and not the first Petition. This court noted that Petitioners have failed to heed this court's citation to C.C.R.C.P. 206.4(c)(1) regarding obtaining a rule to show cause from the court administrator. The Court *Held* the Unopposed Petition of Defendants, Megill Homes, Inc. and Wayne C. Megill to Release, Remove, and Strike Levies from Property filed December 26, 2023 is stricken and the Praecipe for Determination filed February 9, 2024 is stricken without prejudice. The Court noted Petitioners may yet obtain an order containing a rule to show cause per curiam from the court administrator and pursue grant of their Petition as unopposed.

ORDER and MEMORANDUM

AND NOW, this 5th day of March, 2024, upon consideration of the Petition of Defendants, Megill Homes, Inc. and Wayne C. Megill to Release, Remove, and Strike Levies from Property filed February 9, 2024, no response having been filed, for the reasons set forth in the accompanying Memorandum it is hereby **ORDERED** as follows:

1. The Unopposed Petition of Defendants, Megill Homes, Inc. and Wayne C. Megill to Release, Remove, and Strike Levies from Property filed December 26, 2023 is **STRICKEN**; and

2. The Praecipe for Determination filed February 9, 2024 is **STRICKEN** without prejudice.

MEMORANDUM

On December 26, 2023, Defendants, Megill Homes, Inc. and Wayne C. Megill filed their Unopposed Petition of Defendants, Megill Homes, Inc. and Wayne C. Megill to Release, Remove, and Strike Levies from Property. Petitioners averred that “the parties agreed to settle this matter[,] Plaintiffs agreed to dissolve all garnishments, levies, and judgments against Misty Meadows[, and] Plaintiffs are in receipt of all settlement funds associated with the July 28, 2023 settlement.” Petition, 12/26/2023, p. 2. Petitioners attached supporting correspondence to their Petition as Exhibit C and Exhibit D and averred that “[a]s such, Plaintiffs do not oppose this Petition.” Petition, 12/26/2023, p. 4. For relief, Petitioners asked this court to “enter an Order to lift the levy, set aside the sale of any and all properties, and remove any and all lien(s) from the judgment index in Chester County.” Petition, 12/26/2023, p. 4. Petitioners did not obtain a rule to show cause for the Petition, but Petitioners filed a Certificate of Service for the Petition on December 26, 2023 and filed a Praecipe for Determination for the Petition on January 17, 2024.

On January 18, 2024, this court entered an order dismissing the Praecipe for Determination without prejudice. This court noted that no response had been filed to the Petition and that Petitioners had not followed proper procedure to have their Petition granted as unopposed. Order, 1/18/2024, p. 1. This court explained that Petitioners should “obtain the relief requested pursuant to C.C.R.C.P. 206.4(c) (1) (pertaining to issuance of order containing rule to show cause), C.C.R.C.P. 206.3 (pertaining to service and certification of same), and C.C.R.C.P. 206.4(c)(4) (pertaining to motion to make rule absolute and grant petition as unopposed).” Order, 1/18/2024, p. 1.

On February 9, 2024, Defendants filed the Petition of Defendants, Megill Homes, Inc. and Wayne C. Megill to Release, Remove, and Strike Levies from Property, which is presently before this court. The Petition is essentially the same as the Petition filed December 26, 2023 except Petitioners also ask this court to enter a rule to show cause why this court should not grant the substantive relief requested by Petitioners. Petition, 2/9/2024, pp. 3, 4. Toward that end, Petitioners on February 9, 2024 electronically submitted to the court a proposed Rule to Show Cause Order which would require the other parties to file any response to the Petition within twenty (20) days. Also on February 9, 2024, Petitioners filed a Certificate of Service for the Petition and a Praecipe for Determination for the Petition. This court did not enter Petitioners’ proposed Rule to Show Cause Order as an order of court and to date there has been no response filed to the Petition.

First, this court notes that the Petition filed December 26, 2023 is withdrawn by the filing of the second Petition on February 9, 2024. *See Avery v. Cercone*, 225 A.3d 873, 883 (Pa.Super. 2019) (“It is settled law in this Commonwealth that the filing of an ‘amended complaint has the effect of eliminating the prior complaint.’”) (quoting *Hionis v. Concord Tp.*, 973 A.2d 1030, 1036 (Pa.Cmwlth. 2009)). Second, this court notes that the filing of the second Petition was unnecessary since this court struck the first Praecipe for Determination and not the first Petition, itself. Third, this court

notes that Petitioners have failed to heed this court’s citation to C.C.R.C.P. 206.4(c) (1) which sets forth the general rule that “[a]n order containing a rule to show cause, except one which by its terms grants substantive relief or which contains a stay order or seeks to require an answer by respondent(s) in less than twenty (20) days, shall be issued per curiam when presented to the court administrator.” C.C.R.C.P. 206.4(c)(1).¹ Petitioners may yet obtain an order containing a rule to show cause per curiam from the court administrator and pursue grant of their Petition as unopposed.

Accordingly, this court will enter an order dismissing the Petition filed December 26, 2023 and striking the Praeceptum for Determination filed February 9, 2024 without prejudice.

¹ The court will enter an order containing a rule to show cause in exceptional circumstances such as when the court enters a stay or grants substantive relief. *See* C.C.R.C.P. 206.4(c)(2).
