Discovery sanctions – Discovery objections after thirty days

- 1. The failure to file objections within thirty days after being served discovery does not automatically result in the waiver of all objections.
- 2. Discovery sanctions are generally imposed only for violation of a court order.
- 3. The imposition of sanctions always is subject to a balancing test and a weighing of various factors, including the nature of the violation, the length of the delay and its reasons, any prejudice that may have resulted from the delay, and whether the prejudice can be cured.
- 4. Plaintiff sought a court order requiring discovery responses without objections because Defendant did not object to the discovery requests within thirty days. The Court denied that request without prejudice to Plaintiff's right to file a motion to strike or overrule Defendant's objections to the discovery requests.

MEMORANDUM

On July 22, 2022 Plaintiff filed a Motion to Compel Discovery.² On August 16, 2022 Defendant filed a Motion to Strike Plaintiff's Motion to Compel as Moot averring that Defendant has already supplied Plaintiff with the discovery he requested. On August 17, 2022 this court dismissed Plaintiff Motion to Compel as moot while granting Plaintiff leave to file a motion for reconsideration challenging Defendant's averment of compliance.

Plaintiff filed his Motion for Reconsideration on August 18, 2022. Plaintiff argued first that Defendant's discovery response was deficient because Defendant's responses to interrogatories were unverified in violation of Pa.R.Civ.P. 4006(a) (1). Motion, 8/18/2022, ¶¶ 6, 9-11, 15. Plaintiff argued second that Defendant's discovery response was deficient because Defendant objected to some of Plaintiff's discovery requests in violation of the categorical rule in Chester County that a party forfeits its right to object to discovery requests upon the filing of a motion to compel. Motion, 8/18/2022, ¶¶ 6, 9, 12-15.³ For relief Plaintiff asked this court to order Defendant to "provide verified, full and complete specific responses and requested documents . . . within twenty (20) days without objections or face sanctions of this Court upon request for a hearing." Motion, 8/18/2022, ¶ 16.

Defendant filed its Response on August 22, 2022. Defendant averred first that it has cured its omission by sending verifications to Plaintiff. Response, 8/22/2022, ¶ 6. Defendant argued second that depriving a party of the right to raise objection to a discovery request is a sanction within the scope of McGovern v. Hospital Service Association of Northeastern Pennsylvania, 785 A.2d 1012, 1019 (Pa.Super. 2001). Response, 8/22/2022, ¶ 13.

Here, Defendant has cured its initial failure to verify its discovery responses and persuaded this court that Plaintiff's Motion is within the scope of McGovern, which was a case where the appellants raised discovery objections after the thirty (30) day deadlines set by Pa.R.Civ.P. 4006 and Pa.R.Civ.P. 4009.12. Appellees filed a motion to compel arguing that missing the deadline was a categorical waiver of the right to raise objection. The trial court granted the motion to compel and "ordered Appellants to answer all interrogatories and to submit all discovery documents requested by Appellees." 785 A.2d at 1014-15. The Superior Court reversed holding that the failure to file objections within thirty (30) days after being served interrogatories and requests for documents does not automatically result in the waiver of all objections. To the contrary, the Superior Court held that discovery sanctions are generally imposed only for violation of a court order and that "the imposition of sanctions always is subject to a balancing test and a weighing of

various factors." 785 A.2d at 1019. The Superior Court held that the trial court should consider and focus on "a variety of factors such as the nature of the violation, the length of the delay and its reasons, any prejudice that may have resulted from the delay, and whether the prejudice can be cured." 785 A.2d at 1018.

Here, Plaintiff was not entitled to an order requiring Defendant to produce discovery without objection. First, Plaintiff identified no underlying order that Defendant violated that might warrant sanctions. Second, <u>McGovern</u> prohibited this court from treating Defendant's lateness as an automatic waiver of Defendant's right to object and Plaintiff advanced no other ground for relief.

Accordingly, for the reasons set forth above this court will enter an order denying Plaintiff's Motion for Reconsideration filed August 18, 2022 without prejudice to Plaintiff's right to file a motion to strike or overrule Defendant's objections to Plaintiff's discovery requests.


